Topic Original Report

MO- By entering the residence through an open window and trespassing in a permanent habitation when another person was likely to be present.

On 4/12/08, at 1923 hours, officers were dispatched to 2054 Lark Down, for a report of a male who had just entered the house through a window. COM/CONSTANCE FERGUSON advised dispatch that a tall, black male wearing a black hooded sweatshirt had been loitering in her driveway for the last half hour. FERGUSON stated she had been watching him and observed him crawl through the center, first floor window, on the north side of the house.

Upon arrival officers surrounded the house. Ptl. Obrock and I approached the window and observed ARA/BRYAN ROE sitting on the bed. We asked ROE if he lived there. ROE stated he did not. We told ROE to climb back out the window. ROE started to come out and then tried to pull back inside. We were able to grab ROE and pull him out before he could get back into the house.

ROE was handcuffed, Mirandized and placed in the back of cruiser 212. ROE said that he is from Columbus but came to Cleveland to attend school in Parma at the Kaplan Career Center. ROE said he was staying with his aunt in Parma but they got into fight and he has been living on the street ever since. ROE stated that he is friends with OIV/ , who lives at 2054 Lark. ROE stated he met at The Cudell Recreation Center Basketball Courts. ROE said that knew he was homeless and let him sleep in his room sometimes.

I transported ROE back to LPD where he was booked into jail by CO McCarthy for burglary. Upon further speaking to ROE he stated that he just wanted to get his clothes and books from room. ROE stated that was supposed to meet him there but never showed. ROE stated that grandmother, VIC/LULA BRILEY does not know he was there and would probably be mad if he knew.

Prior to leaving the residence officers checked the residence and secured it. Inv. Deucher responded and took photographs of the window. I left a note for BRILEY to contact me on her return home. I was unable to make contact with BRILEY or at the time of this report.
