Topic Original Report

MO: By having in her left shoe a clear baggie containing .33 grams of crack cocaine

MO1: By having in her right front hoodie pocket a glass pipe with burnt residue commonly used to smoke crack cocaine.

MO2: By having in his right front jacket pocket a glass pipe with burnt residue commonly used to smoke crack cocaine.

Sgt. Eschweiler, Sir:

On 4/13/08, at 0427 hours, PTL MOLNAR and I were detailed to the area of the Huntington Bank, on Clifton at Hird, on a report of a suspicious vehicle. The complainant was later identified as COM/ SCOTT RAMPLEY. He is a tow truck driver for Kufner Towing and he advised dispatch that he observed a grey Dodge van drive into the bank lot through the wrong driveway and run over a concrete curb in the parking lot.

I was in the area and observed the grey van pulling onto Clifton from the Huntington parking lot. I stopped the vehicle on Clifton at Fry. SGT. GANNON arrived on scene to assist. I spoke to the driver and she was identified as ARA/ EVELYN CORREA. She advised that she was coming from picking up food. I advised her of the reason for the stop. I spoke to the passenger and he was identified as ARA/MICHAEL WHITSON. He also advised that they were coming from picking up food and he showed me a bag that supposedly contained food, however the bag contained various clothing items. I had WHITSON exit the vehicle. I asked him if he knew the driver and he stated that her name is "Theresa" and he has known her for three months. He stated that he was staying with her at the Days Inn. I spoke to CORREA again and asked if she knew her passenger. She advised that his name is "Michael", but she did not know his last name. She stated that she has known him for a year.

The listed grey Dodge van is owned by OWN/ RAID ABDELHAQ. CORREA advised that she only knows the owner of the van as "Ray". She stated that he gave her permission to use the van and he is also staying at the Days Inn. We attempted to contact ABDELHAQ by phone, but his mother answered and advised that he was not at home. Dispatch called the Days Inn and they advised that no one by that name is on the registry.

Dispatch advised that WHITSON has an active warrant from CCSO for larceny. Dispatch advised that CORREA has an active warrant from Cleveland Hts PD for contempt of court with no original charge listed. Dispatch also advised that CORREA is under a non-compliance suspension from Cleveland Municipal Court from 1/5/07 to 1/5/09 with a FRA attached from 1/5/07 to 1/5/12 and a fee is required. She was not driving due to an emergency.

WHITSON was searched incident to arrest. I located the listed crack pipe in his right front jacket pocket. CORREA was found to have a crack pipe in her right front pocket of her hoodie. They were both secured in handcuffs. WHITSON was placed in the rear of unit #205 and CORREA was placed in

the rear of unit #212.

An inventory of the van was conducted prior to towing. I located the listed Ohio driver's license in the center console. The license belongs to OWN/ DAWN RIZER. No phone number was located for RIZER. The license was confiscated. The van was towed by Kufner Towing where it will be held for OWN/LIC driver.

WHITSON and CORREA were transported to the station. PTL MISCH searched CORREA on the back hill of LPD. CORREA was found to have a small baggie of crack cocaine in her left shoe. It should be noted that she was already issued a misdemeanor citation for drug paraphernalia prior to the discovery of the crack cocaine.

WHITSON's warrant was confirmed by FIKTUS of CCSO and a holder was placed. CORREA's warrant was confirmed by LOVEQUIST, however they advised that they would not place a holder at this time, and they wanted to reconfirm at the time of her release.

CORREA was booked by PTL De. McCARTHY, PTL MISCH and PTL MOLNAR. She was issued citation #M40858 for drug paraphernalia and citation #D161214 for DUS and booked for felony drug possession. A strip search was conducted for the safety and security of the jail and to ensure that no contraband enters the cell block. Nothing further was found.

WHITSON was booked by CO GONZALES . He was issued citation #M40676 for drug paraphernalia. A strip search was conducted for the safety and security of the jail and to ensure that no contraband enters the cell block. Nothing further was found.

RIZER's driver license was tagged and secured in locker#12 in the property room. The glass crack pipes were tagged as evidence and secured in the drug chute in the property room. The crack cocaine was tested in the property room using a Narkit. It tested positive for cocaine. It was tagged, weighed(.33grams), and secured in the drug chute.

WHITSON has a CCH which includes a prior for felonious assault with a hand gun (FB [REDACTED]) and BC [REDACTED]). CORREA has a CCH which includes priors for criminal use of marijuana and criminal use of drugs (FBI [REDACTED])
