Topic Original Report

MO: By entering the victim's residence, through an unlocked door, spraying black paint on the victim's property and leaving without their permission.

Lt. Sprague, Sir:

On 4/14/2008, at approximately 1547 hours, I was dispatched to 14623 Bayes on the report of a residence broken into and vandalized. I arrived on scene and spoke to COM/ THERESA SWEENY. She advised the following.

On 4/14/2008, at approximately 1535 hours, SWEENY went to 14623 Bayes to check for mail. SWEENY advised that this is her father's residence. She stated her father, VIC/ JOSEPH SWEENY, is out of town on business. She stated that he is frequently gone and she checks his mail approximately twice a week. She stated that she entered the residence through the North, front door. She advised that this door was locked. THERESA immediately noticed that there was black spray paint on the South wall of the dining room. She went inside the house and saw that there was black spray paint on the television, phone, and chair in the front living room. She continued into the house and found additional paint in the living room on the hardwood floor, a can of black spray paint and additional black spray paint on the walls of the living room. THERESA exited the residence and contacted LPD via cell phone.

Sgt. Wilkins arrived on scene prior to my arrival. He secured the scene and began to investigate the damage to the residence. Sgt. Wilkins confirmed that there was no additional damage inside the residence. He also confirmed that the rear, South, door was not locked and that there appeared to be a cut screen on the window to the East of the rear door. The rear door was accessible through a back porch area. There were large sheets of drywall leaning against the window, blocking access to it. The rear door appeared to have serious signs of rotting. Its overall condition was poor and it appeared as though it would not be able to be secured effectively. The door leading to from the porch area into the kitchen of the residence was not locked. There was no exterior door handle on this door and it was in general poor condition as well. A security system monitor marked "Honeywell" was found on the South wall of the dining room near the entryway to the kitchen. It did not appear to be set.

Sgt. Wilkins located a note from PO Ortiz taped to the exterior of the back screen door. This note was addressed to the homeowner. It indicated that the resident at 14619 Bayes, OIV/ HARRY PARRISH, contacted LPD on 4/5/2008 to report that the rear screen door was unsecured. The CAD entry associated with this matter noted that the window to the east of screen door was damaged, having a cut screen. PO Ortiz secured the residence and locked the exterior rear door prior to her leaving. PO Ortiz instructed the homeowner to contact LPD when they arrived home if there was any items damaged or missing at the residence.

Inv. Moher responded to the listed address to process the scene. Photos of the damage to the walls, television, floor, chair and phone were taken. A photo of the spray paint can was also taken. This spray paint can was processed for prints with negative results. Inv. Moher found no additional evidence at the scene. He inspected the points of entrance to the residence and found no signs of forced entry.

THERESA advised that she does not know who damaged her father's residence. She advised that

only she and her brother have access to the residence when her father is away. THERESA denied allowing any other people access to the residence. She stated that she last visited the residence on 4/8/2008 at approximately 1600 hours. She found no signs of damage at this time.

I spoke to the neighbors around the listed address with negative results. The resident of 14619 Bayes, PARRISH, advised that he had not seen or heard anything out of the ordinary since he contacted LPD on 4/5/2008. He provided no other information.

On 4/15/2008, I spoke to JOSEPH regarding this matter. He advised that he spoke to his daughter, THERESA, on 4/14/2008. He reported that he did not allow any other people to have access to the residence outside of his daughter and son. He indicated that he did not have any suspects in this matter at this time. He reported that his house was broken into on 2/28/2008 as well. A suspicion report was taken by PO Hayes in regards to this matter. He advised that "some small items" were taken, but failed to elaborate on this. JOSEPH failed to report any items stolen in this report. JOSEPH stated that he had not been to his home in "some time", approximately one to two months. He indicated that he did not set his home security alarm when he left last. He stated that his daughter does not know the code and he did not want to inconvenience her. JOSEPH was instructed to contact LPD should he find additional damage or items missing from his residence.

JOSEPH advised that he desires prosecution. He was informed of the low solvability of this matter.
