Topic Original Report

On 04-16-08, at 1625hrs, I was detailed to 11729 Detroit, CPY/Hi-Fi, for a theft report. When I arrived, I spoke with VIC/JAMES MALER, who said two former employees had taken an electric guitar, two amplifiers, and speaker from the HI-FI without his permission or knowledge.

MALER said SUB/ARIS ALMALIOTIS and SUB/SEAN MCCARTHY were hired to work at the HI-FI as promoters. They had keys to the business as part of their position, as they would also sometimes open and close the business. They also were in charge of all revenue from the kitchen, and profits from promotions. MALER said that on 04-04-08, he received a proposal of a merger with another business, and he would not need ALMALIOTIS and MCCARTHY anymore. He said he told them and asked for their keys. They said they did not have keys with them, and would return them at a later date.

MALER said on 04-07-08, at 0030hrs he was the last to leave the HI-FI, and he locked up the business and set the alarm. He said he opened the business at 0900hrs of the same date, and saw that an electric guitar, two amps and a speaker cabinet were gone. He could see that there was no forced entry, and the alarm was armed. He said he called ALMALIOTIS and MCCARTHY to inquire about the equipment. He said he could not reach either on the phone.

MALER said he posted information on the internet about the incident. He listed the 4 pieces of electronic equipment missing from the HI-FI and explained that ALMALIOTIS and MCCARTHY were his suspects.

MALER said he received a call on 04-14-08, from OIV/JOE KAZAK about the listed electric guitar. KAZAK said that ALMALIOTIS tried to sell the guitar to his son. KAZAK said ALMALIOTIS still had the guitar. KAZAK met MALER and took him to a park in Parma and was able to deliver the guitar to MALER. MALER said KAZAK was on the phone with ALMALIOTIS, and he told KAZAK where the guitar was hidden in the park.

MALER said he was then called by MCCARTHY on 04-15-08, who said the two listed amplifiers and the listed speaker cabinet were at ALMALIOTIS' house, and that he would bring them to the HI-FI. MALER said MCCARTHY did deliver the listed property. MALER said he then got a call from ALMALIOTIS. ALMALIOTIS was angry that MALER had posted the incident on the internet.

MALER said the ALMALIOTIS wanted him to print a retraction about the incident on the internet, because he was still going to work in the area as a promoter. MALER said he would not print a retraction. MALER said ALMALIOTIS then said "I know where you live, I know what kind of car you drive, one way or the other you are going to pay for this".

I asked MALER what he thought ALMALIOTIS meant. MALER said ALMALIOTIS had mailed him something in the past, so he did know where he lived. He also knows what car he drives. MALER said he did not think ALMALIOTIS would come to his house. He said he is afraid that ALMALIOTIS would do something to his car while he is at work at the HI-FI, and wanted us aware of the situation.
