Topic Original Report

M.O. By breaking a window to the front door to gain entry and take a laptop without the permission of the owner and leave with same.

On 4-16-08 at 1149hrs cars were detailed to Elbur between Clifton and Merl on the report of a Tan Jeep Cherokee chasing after a male. Dispatch advised a white female was driving the vehicle. The car was last seen going W/B on Merl. Upon arrival I spoke with WIT/STEPHANIE COLBY who stated the following.

COLBY was sitting in her house at 1172 Elbur when she heard footsteps running down the driveway at 1176. COLBY thought this was suspicious because the house is vacant. When she looked out the window, SUS #1 was jumping over the fence at 1176 heading W/B. She heard SUS #2 yell, "There she is", and run towards a Tan Jeep Cherokee. COLBY saw the Cherokee pull into a driveway across the street, pull out, and drive south on Elbur. COLBY described both males as looking very similar. They were in there late teens early twenties, dark hair and medium builds. SUS #1 was approximately 5'09 to 5'11, wearing a blue baseball cap, long dark sleeve shirt and unknown color tennis shoes. SUS #2 was wearing long Khaki shorts, a light colored long sleeve shirt underneath a dark colored short sleeve shirt. The male was approximately 5'10 with a medium build. COLBY stated she could identify both males if seen again.

COLBY said a white female was driving a 4dr, Tan Jeep Cherokee, with a loud muffler and temp tag on the rear of the vehicle. COLBY said the female had blonde hair pulled back in a pony tail.

INV.WALLING located the suspect's blue baseball cap with a "D" on the front in the back yard at 1176. COLBY identified the hat SUS #1 was wearing. This was later confiscated as evidence, tagged, and placed in the property room locker #18.

While officers were speaking with COLBY, WIT/COURTNEY PURDUM, called from 13422 Clifton stating she had just seen two males leave the driveway at 13425 Clifton and run W/B on the sidewalk. PURDUM stated one of the males dropped a laptop on the sidewalk and kept running. PURDUM'S description was similar to COLBY'S. She described SUS #1 as a white male in his twenties with dark hair, medium build, 5'8 to 6'0 wearing blue jeans and a dark colored jacket. SUS #2 had a medium build, dark hair, blue jeans, mid twenties, with a white football style jersey shirt with blue letters. This male was carrying the laptop. PURDUM stated she would probably be able to identify the males if seen again.

VIC/RUSSELL KOMAROMY came back to his residence at 13425 Clifton while officers were on scene. KOMAROMY stated he came home from a doctor's appointment and saw a white male standing in his front lawn, and another white male standing on his front porch by his front door. KOMAROMY'S description was similar to the others. KOMAROMY said both males appeared to be in there twenties, SUS #1 had brownish hair and a brown jacket. SUS #2 was wearing a blue windbreaker type jacket and a blue baseball cap. KOMAROMY identified the blue baseball hat as the one worn by the suspect. KOMAROMY stated he chased both males west on Clifton and lost them as they ran south on Emerson. KOMAROMY said he pulled down Elbur and saw a Jeep Cherokee with a white female parked on the street. KOMAROMY thought this was peculiar because of the circumstances and wrote down the temp

tag as P081832. In running the plate it lists to SUS/BRANDY HALL. HALL matches the description of the female driver. She does not have a CCH, but has an active warrant out of Brooklyn PD for traffic. KOMAROY said the female had reddish, frizzy hair, and when she saw him writing down the plate she asked him what he was doing. KOMAROY then left. He said he would most likely be able to identify the males if seen again.

KOMAROY said the black, Toshiba laptop came from a dining room table in his living room. When the laptop was dropped, a small cover piece to the back broke off. A small 8" x 8" window pane on the front door to his residence had been smashed in and entry was gained. KOMAROY did not find anything else missing. INV.MALLOY responded and took photos. See his ET sheet for details. A property tag was filled out, signed by KOMAROY, and released to him. We were unable to check surrounding houses due to call volume.

While officers were on scene, dispatch advised they received a call about a white male hiding in the bushes at 1319 Belle. PTL.ROBINSON and INV.WALLING located ARA/MATTHEW MCGRATH hiding near the porch. See PTL.ROBINSON'S report #08-002961 for details. We were not sure if it was related, but Officers transported COLBY, KOMAROY, and PURDUM to 1319 Belle. They all stated MCGRATH was not one of the suspect's.

KOMAROY desires prosecution in this matter.
