Topic Original Report

M.O#1 By willfully fleeing from officers, immediately after the commission of a felony, in a motor vehicle, after being given both audible and visual signals to stop.

M.O. #2 By knowingly being in possession of a vehicle without the owner's knowledge or permission.

On 04/16/08 at approximately 0531 hours, I observed the indexed gold 1990 Honda Accord LIC/EGF5355 traveling northbound on Elmwood. The vehicle turned left traveling westbound on Detroit without using a turn signal. The vehicle's muffler noise was also excessive. The vehicle was occupied by two black males. The driver was wearing a dark colored baseball hat. I was unable to determine the type of clothing the males were wearing.

The vehicle turned left traveling southbound on Mars, then eastbound on Hilliard. I activated my overhead emergency lights, and the vehicle accelerated. They turned right, travelling southbound on Warren. I activated my sirens, and the vehicle continued to accelerate southbound on Warren approaching Madison. The road conditions were dry, and traffic was light. My speed was 60 mph. The vehicle continued southbound on Alger, not stopping for the stop sign, and the flashing red light.

The vehicle continued eastbound on the South Marginal. Traffic was light. Road conditions were dry. I was traveling 70 mph on the marginal. The vehicle entered onto I90 Eastbound, from the South Marginal traveling in speeds over 90 mph.

Due to visual being lost on I-90, just before the West 117th street exit, and rush hour traffic beginning, the pursuit was terminated.

A request for a copy of the in-car video was requested.

Dispatcher MALLOY contacted OWN/MARLA L STROTHER. She was not aware that her car was not in her driveway. She stated this would be the second time that her vehicle was stolen from her residence. She could not provide any suspect information. She was advised to make a report with Cleveland Police. As of 04/18/08, the vehicle is not entered in LEADS as stolen.
