

Topic Original Report

M.O.: By forcefully opening the front door to an upstairs apartment, entering, and taking the listed items without permission to do so.

LT Sprague, Sir,

Detailed to 1594 Ridgewood #4 on 4/17/2008 at 1128hrs on the report of a burglary. The property is a multi-dwelling house with a door on the north side which opens into a common hallway. Four apartments can be accessed from this hallway - two on the first floor and two on the second. Apartment 4 is located on the west side of the second floor.

VIC/WILLIAM LINDQUIST was inside of apartment 4 when I arrived. LINDQUIST advised that he had left to visit family in Minnesota on 3/17/2008 at 0800hrs. LINDQUIST locked a dead bolt on the apartment door when he left. LINDQUIST returned home on 4/16/2008 at 2300hrs to find the door to his apartment wide open. LINDQUIST entered and found the listed TV, DVD player, and subwoofer all to be missing. All three items were located in the SW corner of the south bedroom. LINDQUIST could not produce receipts or serial numbers for the items. LINDQUIST does not know who may have stolen the items.

The door to the apartment had been forcefully opened, with the lock and the door splitting apart. Pieces of wood from the door were found inside of the kitchen. The sliding bolt from the lock was broken loose and could not be located. The door frame did not appear to have any related damage. INV MALLOY was detailed and arrived to photograph the damage.

LINDQUIST advised that apartments 1 and 3 are currently vacant. I spoke with the resident in apartment 2, directly beneath LINDQUIST'S apartment, who advised that he could not recall seeing or hearing anything strange during the timeframe listed above.

LINDQUIST was advised of the low solvability of this incident. LINDQUIST will prosecute if an arrest is made.
