Topic Original Report

On 4-17-08 the complainant, LYNN STEERS, dropped off some paperwork which the subject of this report, \_\_\_\_\_, had been passing around the neighborhood.

\_\_\_\_\_ gave one pack of papers to the complainant's twelve year old son and advised him not to read it, but to give it to his parents. In reading some of the materiel, the complainant did not feel that it should be given to anyone, much less children.

This department has had numerous contacts with \_\_\_\_\_, who is apparently suffering from mental problems which conflict with her daily activities. In the paperwork, \_\_\_\_\_ claimed the state had changed her gender and she has been denied numerous rights and feels cheated and betrayed. She also included a note from someone, a copy of some lab work and her birth certificate.

The complainant stated he and several of his neighbors are concerned about the subjects behavior and feel an unsupervised residential neighborhood is not the best place for a person with such problems to be living in.
