Topic Original Report

MO: By punching victim in the face, causing physical harm.

On 04-18-08 cars were detailed to the area of 1623 Cohasset on the report of a large group of juveniles fighting. Upon arrival, I was approached by (VIC) , and (VIC) JAMES McREYNOLDS, who advised the following.

advised that he was walking home from school on this date, when he was approached by a group of approximately 8-10 juveniles. stated that he only recognized three of the juveniles, whom he identified as (SUS) , (OIV) and (OIV)

As the juveniles approached him, came up to and pushed him in the chest. attempted to walk away, at which time punched him the face with a closed fist. At that point, McREYNOLDS, who lives a couple houses away, came to help

McREYNOLDS stated that when he came to help he got into a verbal altercation with several of the juveniles. The juveniles then "jumped" McREYNOLDS, taking him to the ground. McREYNOLDS stated that he wrestled on the ground with several juveniles before they got off of him and fled South on Cohasset. McREYNOLDS stated that he could not identify who had attacked him, only that there were several. He believes that was one of these juveniles as well.

had a bruise under his left eye, and his nose was bleeding from the punch by He refused medical attention and INV. MOHER arrived on scene and photographed the injuries. McREYNOLDS had scrapes and cuts on his knees and left elbow which were also photographed. He also declined medical attention. Both advised that they desire prosecution.

I spoke with (OIV) VIRGINIA SAKER who confirmed 's account of events. She stated that did not do anything to provoke the altercation, and she believed him to be the victim. She also confirmed that McREYNOLDS had been "jumped" while trying to help

While on scene, SGT. WYNALEK, PO JERDONEK and PO WINTRICK advised that they had located two of the juveniles who were present at the altercation. WINTRICK identified (SUB) and (SUB) who stated that they were present at this incident. stated that he was walking home from school when came to him and said "Do you dare me to hit this kid?" ( ). stated that he just ignored and then witnessed punch for no apparent reason. then stated that McREYNOLDS came over to the juveniles and started fighting with stated that he thought that McREYNOLDS was beating up on too much and he and jumped in to get McREYNOLDS off of him. He denied jumping McREYNOLDS, and stated that he only got involved because McREYNOLDS was beating up on

I spoke with by phone who relayed the same account of events as He also acknowledged that had punched for no apparent reason, but thought that McREYNOLDS had been too rough in dealing with him.

All parties were advised that this report was being taken and would be forwarded to the prosecutor.
