Topic Original Report

M.O.: By entering the victim's apartment, possibly through the dining room window, and taking the victim's underwear and leaving with same.

Sgt. L. WILKINS,

On 4/20/08, at 1835 hrs., I was detailed to 2178 Glenbury (up), on a report of the victim's apartment being entered.

Upon my arrival, I spoke to VIC/LESLIE ROGERS who advised that for the past month and a half, she believes someone has been entering her apartment. ROGERS advised that around 3/27/08, unsure of the time, she came home and found the door to her second floor porch open. ROGERS advised she was positive that the door was closed before she left the house. ROGERS advised that on several occasions, she came home and found either the porch door or the interior front door open. ROGERS advised she never uses the front door.

ROGERS advised that about 2 1/2 weeks ago, she came home and found an empty Marlboro cigarette pack laying on a chest in her living room and her apartment smelled like cigarette smoke. ROGERS advised she or any of her friends do not smoke Marlboro cigarettes and she never smokes in her apartment. ROGERS also stated that there were butts from the cigarettes on the ground outside the house. She saved one of them. ROGERS advised that back on 4/18/08, she found 2 heart shaped suckers in her mailbox and 1 in her bed. ROGERS advised back on 4/13/08 she brought a new bed frame and set it up. On 4/16/08, she noticed some type of white stain on the frame along the foot of her bed. ROGERS advised the stain was not on the frame when she set it up and she did not have any company over that may have left it.

ROGERS advised she believes whoever is coming into her apartment may be gaining access through the dining room window located on the first floor. ROGERS advised on a few occasions, she saw that the window and outer screen to VIC/ERRIN CLOSE's apartment was open. ROGERS advised that she is good friends with CLOSE and they do not lock their interior back doors. ROGERS advised the only thing missing from her apartment were 2 pairs of underwear that were in the basement.

I spoke to CLOSE who advised the same as ROGERS. CLOSE advised she was aware that her dining room window and screen were found open on several occasions, but she was not concerned about it. CLOSE advised she recently kicked her husband out of the house and she believed that is how he got back into the house to get some of his property. CLOSE advised that since then, she has talked her husband and she does not believe it was him entering the house. CLOSE advised on one occasion, she noticed that someone may have gone through some of her financial papers that she keeps in a clothes basket. CLOSE advised nothing from her apartment has been taken.

I asked CLOSE and ROGERS why they never called the police about this in the past. They both advised that they are bartenders and they deal with "stalkers." They stated they are used to dealing with strange people. CLOSE advised she only deals with one person that she believes is "stranger than the rest."

CLOSE advised OIV/EDWARD SHANER is that party. CLOSE advised she thinks it is odd, since

things have been happening, that she has been receiving text messages from SHANER more frequently. CLOSE advised she does not believe he is the party entering the house. ROGERS stated that she had been stalked before when she lived in Strongsville. ROGERS stated that she had received strange calls and was watched while she was in her apartment. ROGERS advised she is made a report with Strongsville PD but she is not sure what happened with it.

In checking the house, it is a duplex. The first floor is 2176 and the second floor is 2178. The dining room window is on the North side of the house. There weren't any signs of force to the exterior of the house, except for the screen to CLOSE's dining room open by about 1". I did not talk to any of ROGERS or CLOSE's neighbors because since they noticed things have been happening, they stated they have been talking to them. ROGERS advised the neighbors advised they have not seen anyone around the house. ROGERS also advised that two of her neighbors have been watching the house for them. Inv ALLEN responded for ET. Inv ALLEN took custody of the suckers, cigarette pack, cigarette butt and the sheet from her bed.

Both CLOSE and ROGERS advised they do not have any suspects. They advised they desire prosecution if suspects are developed. ROGERS stated that she believes whoever is doing this may have been watching her for a while because things started to happen right after her roommate and CLOSE's husband moved out. Both ROGERS and CLOSE stated the ex roommate and husband don't have anything to do with this.
