N A R R A T I V E 1	Topic Original Report M.O: By making a comment to the victim that he was going to kill her then himself and then taking a handgun from the truck of his vehicle and placing it in the back waist band of his pants then following her to another bar. M.O:By running from the police with the purpose to obstruct and impede a police officer in the performance of his duties. M.O.: By being voluntarily intoxicated with a strong odor of an alcoholic beverage on his person, slurred speech, and glassy and bloodshot eyes. Being a danger to himself and others. Sgt. L. WILKINS, On 4/21/08, at 0148 hrs, cars were detailed to Detroit and Edwards on a report that a male had a gun in the trunk of his Black Chevrolet Cobalt parked in the area. Upon officers arrival, we observed the indexed vehicle parked on Detroit just east of Edwards. The license plate on the vehicle was DRJ7079 which listed back to ARA/STEVEN LAMB. There was a group of about 6 to 8 people that came walking out of the Lakewood Riveria, 16719 Detroit, that were yelling. The people crossed over to the corner of Detroit and Edwards. As officers went to talk to them, all but one of them crossed back over to Lakewood Riveria. One male wearing a grey hooded sweatshirt continued Northbound on Edwards. The male looked back at officers then he ran Northbound then East into the yards. Officers checked the area but was unable to locate him. A unknown male came over to officers and advised us that the male that ran supposedly had a handgun in the waist band of his pants and that he threatened a female at Pacers, 14600 Detroit Avenue. A few minutes later, the male came walking Westbound through the parking lot of the Friendly Mini Mart located at 16701 Detroit. When the male saw officers, he turned around and started running Northbound of Ethel. Officer RODA and Inv PICKENS went down Ethel after him. I stayed on Edwards and saw the male running Northbound behind the Friendly Mini Mart. Other officers arrived on scene and set up a perimeter. Officer OBROCK and his partner SHEP arrived and started to search the area. Officer CANTLIN located the male walking Northbound on Ethel by the railroad tracks. The male was identified as ARA/STEVEN LAMB, who was advised he was under arrest for Obstructing Official Business. In talking to LAMB, it was found that he was intoxicated. LAMB was advised of his Miranda rights, which he stated he understood and claimed he wanted his attorney. LAMB was transported to the police station by Officer RODA where he was booked by Officer PERHACS. LAMB was issued citation # M39644 for Obstructing Official Business and #M40755 for DCI. LAMB's vehicle was towed by Kufner's Towing to be held for the owner and license driver. Nothing of evidentiary value was located in LAMB's vehicle. Officers checked the area of Edwards and Ethel but were unable to locate any weapon. VIC/JENNIFER MILES called LPD and wanted to talk to officers about what had happened. MILES advised that she has been dating LAMB for a while. MILES advised lately he has not been acting right "mentally." MILES advised about 4 months ago, LAMB called her and told her that he was going to kill

himself. LAMB threatened that he had a gun and that he was "going to put in his mouth." MILES advised that she talked to him for several hours before he calmed down. MILES stated that while she was talking to him, she could hear him cocking a gun. MILES advised that LAMB owns two handguns. LAMB keeps a gun in the trunk of his vehicle and the other one at home. MILES advised on 4/17/08, she got into a heated argument with LAMB. MILES did not say what the argument was over. MILES stated at one point, she told LAMB, "why do you just shoot me?" LAMB replied that he "has plans on taking them both out". MILES advised she believed that LAMB meant that he was going to kill her and then himself. On 4/19/08, MILES told LAMB that she believed that she needed some space from him and he got angry.

On 4/20/08, LAMB came to Pacers to talk to her but she advised him that she was busy and that he should just call her later. Around 0100 hrs., LAMB called and MILES advised him that he could come to Pacers and talk to her. LAMB arrived there a short time later. MILES advised that LAMB wants to talk and spend some time with her and she advised him that he could not do that. LAMB got angry at her and started to yell at her. MILES called her friend WIT/LINDSAY RANDOLPH and told her to come pick her up. RANDOLPH arrived and parked behind LAMB's vehicle. MILES walked away from LAMB and got into RANDOLPH's vehicle. MILES advised LAMB walked over to his vehicle and opened his trunk. MILES stated LAMB pulled out a black semi automatic handgun from his trunk and placed it in the back waist band of his pants. At this point, RANDOLPH pulled away and they went to Lakewood Riveria. MILES advised they saw LAMB park his vehicle on Detroit as they went into the bar. About 15 minutes later, someone advised MILES that LAMB was inside Lakewood Riveria. MILES advised that some of her friends and other people ended up walking LAMB outside when they saw LPD outside. See the attached statement for details.

Officers spoke to RANDOLPH who advised that she received a call from MILES asking her to pick her up. When she arrived at Pacers, she observed MILES and LAMB arguing. RANDOLPH advised that when MILES got into her vehicle, LAMB walked over to his trunk and pulled out a black handgun and placed it in the waistband of his pants.

MILES advised that she is afraid that LAMB may do something to harm her. MILES stated that she desires prosecution and wants a protection order. I asked MILES why she did not call LPD about LAMB. MILES advised that LAMB keeps telling her that he has a friend that is a police officer at LPD. She is afraid that nothing would happen to him and he would hear about it and just make him more angry.
