

Topic Original Report

M.O.: By entering the unlocked front door and taking victim's guitar, television, DVD player, and assorted DVD movies without victim's permission.

Lt. Warner, Sir:

On 04/21/2008, at 2101 hours, Inv. Mladek and I were dispatched to 2075 Chesterland Ave. on the report of a break-in. On arrival, I met VIC/REONNA I. DONOVAN, and her son, OIV/

advised that he left the house at approximately 1300 hours, on 04/21/2008.

When he returned, at approximately 1530 hours, he noticed that the television, DVD player, and approximately 40 DVD movies were missing from the living room in the front of the house. He also noticed that a guitar from his bedroom upstairs was missing. called REONNA. REONNA arrived at approximately 2030 hours, and called LPD.


admitted that he left the front door unlocked when he left the house at 1300 hours. advised he often does this because he frequently does not have a key.

On inspection, it did not appear that the house had been thoroughly searched or ransacked. advised that no drawers or doors were open anywhere in the house when he arrived home, and that the remaining items in the house did not appear to have been disturbed.

It should be noted that a jar of change in the front room, as well as another in a bedroom upstairs, were not taken. REONNA also showed me checkbooks and credit cards stored inside a bureau, as well as two computers, that were not taken.

Inv. Mladek processed the scene for evidentiary purposes. We knocked on doors at 2069, 2071, 2072, 2078, and 2079 Lark. None of the residents saw or observed anything of a suspicious nature.

REONNA desires prosecution. Neither REONNA nor had any suspects in this matter. REONNA was advised regarding solvability.
