N A R R A T I V E 1	Topic Original Report	<p>MO #1-By entering the residence at 1439 Winchester and cutting copper pipes intending to leave area with same.</p> <p>MO #2-By using the indexed duffel bag and gloves as tools in the commission of a crime.</p> <p>MO #3-By hiding in the crawl space of the victim's home, refusing to exit, after being advised of his lawful arrest and instructed to come out.</p> <p>MO #4-By being in possession of a glass pipe containing suspected crack cocaine residue.</p> <p>Detailed on 4-22-08 at about 0925 Hrs. to 1439 Winchester Ave. on the report of a male and female observed entering an unoccupied home. On Officers arrival I spoke to COM/RUTH GEHRMAN who advised the following.</p> <p>GEHRMAN was outside with her dog and observed a male and female enter the side door of the home across and one south of her. GEHRMAN stated that she noted that it appeared that both parties were wearing backpacks. GEHRMAN stated she knew that the owner of the home, VIC/MATTHEW DEGRANDIS, had been doing some renovating at the property but as far as she knew, no one was living there yet. GEHRMAN further advised that she did not see either of the parties that entered the home leave before any of the Officers arrived on scene.</p> <p>DEGRANDIS was then contacted at the number he had posted on the "For Rent" sign clearly placed in his front yard. DEGRANDIS advised that he would be available to respond to the scene in a short time.</p> <p>While waiting for DEGRANDIS, Officers began to check the home. The home was found to be secured with the exception of the northwest side basement window. This window was found to have the screen removed from the frame and it was then forced open. This was later determined to be the point of entry.</p> <p>DEGRANDIS then arrived on scene. At this time Sgt. Spaetzel and I entered the home to search for these parties. The first and second floor were found to be secure and we then responded to the basement. As Officers did so scraps of broken copper pipe were laying on the ground. The indexed duffel bag was also found which contained a number of other copper pipe pieces. The indexed gloves were observed on the landing directly above the bag. All of these items were later confiscated as evidence by Inv. Malloy. As Sgt. Spaetzel turned the corner to the east next to the hot water tank, he located a female, later identified as ARA/CHARLENE DAVIS. CHARLENE was pulled back from where she was attempting to hide and advised she was under arrest for Breaking and Entering. CHARLENE was secured and escorted out to the rear of car 203.</p> <p>In further checking the basement a crawl space was found. Attempting to hide in this space was another male. This party was later identified as ARA/JERRY ELLIS. ELLIS was repeatedly told to come out from where he was hiding and that he was also under arrest for Breaking and Entering. ELLIS refused to do so. Sgt. Spaetzel advised that should ELLIS not voluntarily come out a K-9 would be requested to the scene and sent in after him. This still did not deter ELLIS and no conversation was exchanged with any Officer. It is believed that ELLIS thought no one could see him in his location and continued to hide until we would finally leave the scene.</p>

Finally ELLIS spoke and agreed to come out. ELLIS was then secured and placed in the rear of car 219. Ptl. Pietch stated that ELLIS had admitted coming to the area today with CHARLENE in the indexed truck. The truck was later found to belong to CHARLENE's ex-husband, OWN/WILLIAM DAVIS. CHARLENE was also asked about this and admitted that they did. CHARLENE had the ignition key for the truck in her right coin pocket of her jeans. CHARLENE was asked if there was anything illegal inside the truck that Officers should know about. CHARLENE admitted that there was a drug pipe in the center console of the auto that belonged to her. A tow was then ordered for the truck incident to their arrests.

While inventorying the truck, Ptl. Pietch advised that he found the indexed crack pipe where CHARLENE stated it was. CHARLENE was additionally advised she was being charged with Possession of Criminal Tools and Possession of Drug Paraphernalia. CHARLENE was then transported to LPD by this Officer and later booked by CO Gonzalez, Ptl. Piechowiak and dispatcher KAVOURAS.

In running ELLIS, he was also found to have an outstanding warrant with LPD for C of C/Petty Theft. ELLIS was then advised he was additionally being charged with Possession of Criminal Tools, Obstructing Official Business and Warrant Served. ELLIS was then transported to LPD and booked by Ptl. Pietch and CO Gonzalez.

Inv. Malloy did the ET work at the scene. Inv. Malloy also tagged and transported the duffel bag and gloves to the property room where they were secured in the property room. This Officer transported and tagged the indexed drug pipe. The pipe was then placed into the property chute after being marked as evidence.

In checking ELLIS, he was found to have a CCH on record. ELLIS' FBI number is [REDACTED] his BCI number is [REDACTED] and he has no Lakewood Identification number.
