Topic Original Report

MO:By being in possession of a pipe commonly used to smoke drugs which contained fresh marijuana.
 MO:By being in possession of a baggie of marijuana weighing 3.28grams of marijuana.
 MO:By being a city park after 11:00pm and before sunrise.
 MO:By being out on city property between the hours of 2300hrs and 0600hrs.
 MO:By being 17 years old and in possession of tobacco products.

Sgt Eshweiler Sir:

On 4/22/08, at 2339hrs, I was on patrol in Lakewood Park, 14532 Lake. There was a parked car in the parking lot near the women's pavilion. I began checking the park for the occupants of the auto. Ptl Mullen arrived to assist.

We could hear parties talking down by the break wall, located in the lower N/E corner of the park. We approached them and identified them as ARA/TAYLOR SWINDELL, ARA/GENA SMITH, ARA/RYAN JOHNS, ARA/DAVID MOORMAN and ARJ/. They were all advised that they would be cited for violating Park Curfew. advised that she was only 16 years old.

was placed under arrest and searched incident to arrest. Located in 's purse was the listed glass pipe with fresh marijuana, a baggie containing marijuana, a cylindrical grinder containing marijuana and an open pack of Newport cigarettes. was advised of her additional charges.

SWINDELL,(M40058), SMITH,(M40057), MOORMAN,(M40212) and JOHNS,(M40213) were all cited for Park Curfew and released. was secured in the rear of car #217 and transported to LPD. was released to her father on the back hill. She was issued citation D161465 for Possession of Tobacco by a Minor.

The marijuana, drug pipe, grinder, and tobacco was confiscated, tagged and secured in the drug chute.
