Topic Original Report

M.O.: By being in possession of marijuana in less than bulk amount.

Sgt. L. Wilkins, Ma'am:

On 4/23/2008, at 2007 hours, officers were dispatched to Lakewood Park on a call from COM/KURT MATEJ stating there were several juveniles in the park that appeared to be in possession of drugs. MATEJ described the juveniles as white males, wearing black clothing and walking toward the Women's Pavilion from the playground.

Upon arrival, I observed ARJ/ V and OIV/ M matching this description, walking near the Women's Pavilion. V and M were advised of the complaint and denied having any drugs. V and M both granted consent to search their persons. The listed marijuana in a plastic baggie was located in V's left front pants pocket. This marijuana was later found to weigh 2 grams. Nothing was found during the search of M.

V was placed under arrest for Drug Abuse and secured in Unit 215. At this time, MATEJ approached and pointed out a Ford Escort that was leaving the park. MATEJ stated one of the male's involved in the drug activity was in the Ford Escort. Inv Pickens was arriving on scene and stopped the vehicle near the entrance to the park.

The driver was identified as ARJ/ K. K granted consent to search his person and stated he had marijuana in his pocket. A plastic baggie containing marijuana and a rolled piece of paper containing marijuana were found in K's right front pants pocket. This marijuana was later found to weigh .5 grams. K was placed under arrest for Drug Abuse.

V was released to his mother who arrived at the park. K and the Ford Escort were released to K's father, OWN/RONALD K, who also arrived at the park.

The marijuana was tagged and placed in the property room drug chute.
