Topic Original Report

M/O: By the suspect forcing open the victim's apartment door by kicking same, entering the apartment and damaging the victim's listed property.

Sgt. Wilkins,

On 04/24/08, at approximately 1916 hrs., P.O. GREEAR and I were detailed to 11820 South Lane #6 on a report from COM/JOHN DONAHUE that the apartment door had been "kicked in."

I checked the apartment and determined that no one was inside, however, there were several items that had been damaged.

DONAHUE advised that just prior to contacting LPD, he received a call from WIT/YOLANDA REAVES. REAVES advised DONAHUE that someone had broken into apartment #6. DONAHUE then contacted LPD.

In speaking with REAVES, she stated that she heard someone knocking on the front door to the apartments. She stated that someone opened the door for whoever was knocking. She then heard someone walk up the stairs and knocking on an apartment door. REAVES stated that she then heard a loud "crunch," which she believed was the door to #6 being forced open. She then heard glass breaking. REAVES opened her door to see what the "commotion" was. She stated that she saw that the door to #6 was broken and heard "a male" running towards the door. REAVES became frightened and closed her door. She then contacted DONAHUE.

P.O. GREEAR and I checked with all of the other neighbors but received no response at any of the doors.

The inside of the door frame had been broken loose, and was on the living room floor. In checking the inside of the apartment, a glass table top, just inside the door, had been broken. A television, cable box, and DVD player in the living room had been pushed off of an entertainment stand. None of this equipment appeared to be damaged. A mirror in the bedroom had also been broken. The television in the bedroom had been pushed off of the dresser it was on but did not appear to be damaged.

INV. PICKENS found nothing of evidentiary value and photographed the damaged items.

The victim resident, later identified as VIC/MILAGROS SERRANO, was not home at the time. I left a note for her to contact me with a business card.

SERRANO later responded to LPD and spoke with P.O. RUSNAK concerning her ex-husband, SUS/WILLIAM SMITH. (SEE RELATED REPORT #08-003156 FOR DETAILS)

At this time, SERRANO had not been to her apartment and was unaware of the damage.

I later spoke with SERRANO. She stated that SMITH is upset because she made a DV report with LPD which led to us obtaining the outstanding warrant for his arrest. She believes that SMITH damaged her property in retaliation for this, and added that he knows when she works and would have

known she would not be home when he arrived. SERRANO checked the apartment and nothing had been taken.

She desires prosecution and a request for SA was placed in the Roll Call Book.
