Topic Original Report

M/O: By punching his girlfriend in the face and then striking her head and face against a concrete door stoop repeatedly causing physical harm.

Sgt. L. Wilkins;

On 04/24/08, at approximately 0030 hrs, officers were detailed Code 3 to the area of Edgewater and Cove on numerous reports of a person having been stabbed. Dispatch advised that the suspect was a black male last seen fleeing on foot S/B on Cove.

I located VIC/ and WIT/MARGARITE CONSTANTINE on Cove near Edgewater. stated that no one had been stabbed. She claimed that her boyfriend had "beat me up again." identified him as ARA/GREGORY HOLMES. She stated that he was wearing blue jeans, a white t-shirt, and a black coat. An unknown male, who was in the area, stated that he had seen HOLMES walking E/B on Lake. This information was radioed to other officers and P.O. SCHAD located HOLMES in front of 11860 Clifton. P.O. GREEAR and P.O. HAYES responded to his location to assist.

had a laceration above her left eye that was bleeding. The left corner of her mouth was bleeding, and her right cheek was severely swollen and beginning to bruise. INV. ALLEN later photographed these injuries. was speaking with LFD paramedics so I began to check for witnesses.

CONSTANTINE advised that she had been walking her dog and saw HOLMES "smashing" head into the concrete. She stated that HOLMES was holding by the hair while he was doing this. I had P.O. HARNER speak with CONSTANTINE further but she refused to give a written statement.

I advised the other officers to place HOLMES under arrest for Domestic Violence. He was handcuffed, searched, and secured in unit #211. They then transported him to LPD jail. At the time of his arrest, HOLMES was intoxicated. I was advised that he had a moderate odor of an alcoholic beverage on his breath, his eyes were glassy and bloodshot, and his speech was slurred. He was booked in by P.O. GREER, P.O. HAYES, and INV. ALLEN for Domestic Violence and Intox.

was transported to Lakewood ER by Squad 3.

had also been drinking and stated that she had "two cans of beer." was not intoxicated.

stated that she and HOLMES had taken her dog outside and she was sitting in the doorway. She stated that HOLMES asked her to open the door so that he could go back inside and when she said no, he "freaked out" and began punching her in the head. That was all she could remember.

refused to give a written statement. She further advised that she does not desire prosecution or a T.P.O. She stated that "all my neighbors" saw what happened, and that was all we

needed to "put him away." stated that HOLMES has "beat her up in the past" and she wants to get away from him but still would not cooperate by providing a written statement.

added that HOLMES had just "done six months" for the last time he beat her up and that "he needs to go to prison again."

was given a resource card.

was treated by DR. DEEHRING. At the time of this report, the extent of injuries were unknown, so it was undetermined if would be admitted or treated and released.

It was later learned that HOLMES has a previous Domestic Violence conviction from September of 2007 where was the VIC as well. HOLMES was charged with Domestic Violence (F5).

I obtained a copy of the 911 calls made to LPD in regards to the incident. I tagged the CD and secured it in locker #18 the LPD property room.

I contacted the Domestic Violence Hotline and gave all of the pertinent information to Elaine BUTLER.

HOLMES has a CCH with FBI# [REDACTED], BCI# [REDACTED] and Lakewood #23539.
