<p>M.O. - By entering the unlocked vehicle and removing the car stereo from the dash without permission.</p> <p>On 4/24/08, at approximately 0259 hrs, officers were detailed to the area of 13603 Madison on the report of two males going through a vehicle in the later.</p> <p>Upon arrival, it was discovered that the listed Kenwood car stereo was taken from the dash of the listed Saturn vehicle. At that time, the owner, VIC/ CRYSTAL BRADFORD, was unable to be reached by phone and a message was left for her.</p> <p>I later spoke with BRADFORD who stated that she had left the vehicle parked in the parking lot next to the Grafton Street Pub so she did not have to drive home. The vehicle was unlocked at that time.</p> <p>When she was advised of the incident, she stated that prosecution is desired for the theft of the stereo.</p>
