Topic Original Report

M.O. - By forcing victims into an alley at gunpoint and taking their money, purses, and other items without permission.

On 4-25-08, at approximately 0255 hrs, officers were detailed to the area of 12201 Madison on the report of parties having been robbed at gunpoint. Prior to officers arriving on scene, dispatch stated that the suspects in the robbery were a white male and a black male with silver handguns. Dispatch also stated that this occurred in the alley next to an apartment building off of Madison and the victims were walking W/B on Madison near Winchester.

Upon arrival, Inv. Pickens began speaking with VIC/ TARA SCHAFER, VIC/ LISA LORION, and VIC/ ARTHUR SOUSA. At that time, they were able to give some descriptions of the males who had robbed them. Both males were approximately 20 - 24 years old and both had small silver handguns. The white male was approximately 5'6 - 5'7, 150 - 160 lbs, wearing a dark ball cap, blue jean shorts, and a red and white shirt. The shirt may have been some type of hockey jersey. The black male was approximately 5'5 - 5'6, 160 - 170 lbs, also wearing a ball cap, jean shorts, a light colored shirt, and white shoes.

Officers began checking the area at that time for the suspects, but none were located.

In further speaking with SCHAFER, LORION, and SOUSA, it was learned that they were walking home W/B on the south side of Madison from the Flying Rib bar. When they approached the west side of the apartment building at 12201 Madison, the two suspects walked out of the parking lot of the apartment building toward them. At that time, both males pointed small silver handguns at SCHAFER, LORION, and SOUSA and said "You know what this is. Walk back here." At that time, the suspects took them into the parking lot to the west side of the apartment building and behind a small fence near the trash cans and stated "Give me your purse and give me your money".

The males then grabbed SCHAFER's purse and LORION's purse and took them away from the victims. The white male then checked SCHAFER's pockets and the black male checked SOUSA's pockets. As they were doing that, LORION heard one of the males say "Jay, he doesn't have anything." LORION was not sure which male said that, but believes it may have been the black male talking to the white male.

When they finished checking SOUSA's and SCHAFER's pockets, they told them to "Keep walking and don't look back." They pushed LORION, SCHAFER, and SOUSA back out towards Madison at that point. As LORION, SCHAFER, and SOUSA walked W/B on Madison, they tried to look back to see which way the suspects left, but could not see them after they got back out onto the sidewalk. They stated they did not hear or see any vehicles leave the area and did not see the males anywhere on Madison. After they walked W/B for a couple of blocks, SCHAFER found her cell phone in her jacket pocket and contacted LPD.

SCHAFER stated they were unable to give any other details at that time, because everything happened so quickly. She stated that they were only in the alley behind the building for a couple of minutes. SCHAFER, LORION, and SOUSA all stated that they had never seen either of the suspects before and did not remember seeing them in the Flying Rib while they were there. SCHAFER believes that she

may be able to identify the white male suspect again if she were to see him, but she does not believe she would be able to identify the other male for sure. LORION and SOUSA both stated they did not get a good look at either of the males faces.

While information was being gathered from the victims, officers had set up a perimeter in the area. Ptl. Schad and Canine Arco and Inv. Allen began searching the area for the suspects, but no one was located and none of the stolen property was found either.

Inv. Pickens took SCHAFER, LORION, and SOUSA home at that time. They were advised to find any serial numbers and account numbers of any of the items they had taken, to provide them to LPD. They were also advised to contact LPD should they have any other relevant information to the incident. SCHAFER, LORION, and SOUSA all advised that prosecution is desired should any suspects be located. One statement was obtained from the victims and all three of them signed it.
