Topic Original Report

MO: By allowing unreasonably loud music to be played in the bar, with two exterior doors open, causing a disturbance in the neighborhood.

On 04/25/08, at 0054 hrs., I was detailed to Cronies, 17900 Detroit Ave., for a report of loud music coming from the bar. As I was approaching the bar from the east, I could hear loud music coming from the east side parking lot. The east side door of the bar was propped wide open and when I stopped in front of the bar, I noticed that the front door was also wide open. INV ALLEN arrived on scene to assist.

I turned on my In-car camera/microphone then exited my vehicle. I asked the male working the front door to summon the manager. (ARA)TAYLOR FRIEDRICH came outside to speak with officers. I advised him of the complaint -- the loud music coming from the bar. FRIEDRICH stated that the side door was closed, but explained that he turned his back for a while as he watched the basketball and baseball games on television. He did not see the door was propped open. The employee working the front door did admit that he had the door open. He knew he could not do this with the extremely loud music playing inside. When I asked FRIEDRICH for his information he said. "It's still the same as it was the last time you were here." FRIEDRICH admitted to being warned in the past about the noise.

FRIEDRICH was issued citation #M40230 for Noise Disturbance and advised of his court date and time. FRIEDRICH was also advised to inform all other employees regarding the Noise Disturbance Ordinance. A video/audio request was submitted to Ken DUNN.
