	<p>MO- By being 18 years of age and consuming and possessing alcoholic beverages.</p> <p>On 4/26/08 at 0110 hours I observed two males in the parking lot of Moon's Beverage, matching the descriptions of two males who had run from LPD earlier. I stopped to identify the males and see if they were involved in the incident. As I walked up I observed ARA/RYAN NEWSOME drop a 24 ounce can of Steel Reserve Beer next to the indexed Dodge Neon. Upon getting closer to the car I could observe another can of Steel Reserve Beer, open in the vehicle.</p> <p>I identified NEWSOME and saw that he was 18 years of age. His friend, ARAJERMAINE FARLEY was also 18 years of age. Both FARLEY and NEWSOME smelled of an alcoholic beverage and admitted to drinking. NEWSOME was issued citation M40867 for Sales to Minors. FARLEY was issued citation M39645 for Sales to Minors. OWN/ROBIN NEWSOME was called, arrived on scene and took possession of her vehicle. Both FARLEY and NEWSOME were released on citation, to ROBIN. Inv. Pickens photographed the beers, which were then dumped out and disposed of on scene.</p>
