Topic Original Report

MO: By forcing their way through the victims door by knife point and assaulting the resident.

MO: By being voluntarily intoxicated, creating a risk of harm to himself and others due to his condition.

On 4/26/08, at 0303 hrs., units were detailed code 3 to 1633 Westwood, on a call from, VIC/KIMBERLY GROVE, stating her upstairs neighbors forced their way into her house with a knife and were assaulting her boyfriend, VIC/GERALD MUSKIEWICZ.

On arrival officers spoke with GROVE and MUSKIEWICZ and they advised the suspects, ARA/JOSHUA MAUNUS and ARA/SHAWN MAUNUS, had gone back upstairs to their residence. MUSKIEWICZ was bleeding from a laceration above his left eye. Officers requested a squad to look at MUSKIEWICZ injuries. MUSKIEWICZ stated he and GROVE were on the front porch having a cigarette when they heard pounding at the back door. MUSKIEWICZ said he opened the door and JOSHUA pulled a knife out from behind his back and forced his way into the kitchen. MUSKIEWICZ stated JOSHUA was attempting to stab him. MUSKIEWICZ grabbed JOSHUA'S right arm and was able to hold him back. MUSKIEWICZ stated SHAWN came in at this time and took the knife. MUSKIEWICZ said JOSHUA and SHAWN both started beating him. They took him to the ground and continued to beat him. MUSKIEWICZ advised JOSHUA'S wife, OIV/NICOLE MAUNUS, arrived and was able calm JOSHUA and SHAWN down and get them off of him. GROVE confirmed MUSKIEWICZ'S account of the events. MUSKIEWICZ stated he had no idea why JOSHUA and SHAWN attacked him.

MUSKIEWICZ was transported to Lakewood Hospital ER by squad #1. INV. PICKENS recovered a steak knife in the back hall outside the kitchen. INV. PICKENS took photos of the knife and MUSKIEWICZ'S injuries. MUSKIEWICZ stated he was punched several times in the head and face causing the laceration above his eye.

Officers responded upstairs and spoke with SHAWN and JOSHUA. SHAWN had blood on his chest and JOSHUA had blood on his face and back. Neither SHAWN nor JOSHUA had visible injuries to account for the blood on them. Neither JOSHUA or SHAWN were wearing shirts. JOSHUA stated he was upset because GROVE was sending NICOLE messages complaining about a noisy fan. He said he went down stairs to talk to her about it and got in a fight with MUSKIEWICZ. He denied having a knife. In speaking with JOSHUA I could detect a strong odor of an alcoholic beverage coming from his person. JOSHUA'S SPEECH was slurred, he was unsteady on his feet, and his eyes were bloodshot and glassy. SHAWN stated he heard a female screaming from downstairs. He went down stairs and observed JOSHUA in a fight with MUSKIEWICZ. SHAWN said MUSKIEWICZ and JOSHUA were struggling with a knife. SHAWN grabbed the knife and tossed it away. SHAWN advised he was trying to break up the fight. Officers did not locate any matching knives in SHAWN and JOSHUA'S home.

JOSHUA and SHAWN were advised they were under arrest for aggravated burglary. They were both handcuffed and secured in the back of unit #217 and transported to LPD by this officer. While in the stall, INV. PICKENS took photos of the dried blood on JOSHUA and SHAWN. SHAWN was not intoxicated, and was booked in by myself and CO MCCARTHY for Aggravated Burglary. JOSHUA was booked in by INV.PICKENS and CO MCCARTHY for Aggravated Burglary and DCI. JOSHUA does not have CCH. SHAWN has a CCH FBI# [REDACTED] and BCI# [REDACTED] for Drug Trafficking.
