<b>N A R R A T I V E</b>  <b>1</b>	Topic Original Report	<p>M.O. By forcing open rear apartment door, entering residence, and taking 20 DVDs without owners permission</p> <p>On 4-26-08 at 1354 hours cars were detailed to 2015 Lakeland #3 on report from VIC/SHERRIE WILLIAMS that her apartment had been broken into today or last night. Upon arrival, I spoke with WILLIAMS who advised she left her apartment at 2130 hours last night and returned home at 1300 hours today. She entered through the front door, which was locked. She then noticed approximately 20 childrens DVDs were missing from the wood shelf next to her TV in the living room. WILLIAMS then found her north facing rear door slightly open and damage to the dead bolt.</p> <p>The rear door had slight damage to the frame near the dead bolt and appeared to have been forced open. There was nothing else disturbed or stolen from the apartment other than the DVDs.</p> <p>WILLIAMS stated that she believes SUS/BILLY BLAIR may be responsible for the theft. WILLIAMS has been friends with BLAIR for awhile and has him over to apartment on occasion. WILLIAMS lives in the neighboring apartment building and the back door to her apartment can be seen from his apartment. Last night, prior to WILLIAMS going out, BLAIR asked her to go out with him and play pool. WILLIAMS declined the invitation, saying that she was going over to her boyfriends in North Olmsted. This made BLAIR angry and caused a fight. WILLIAMS advised BLAIR had been drinking heavily yesterday.</p> <p>Inv. Malloy responded to the scene and found NOV. See his photo sheet for additional information.</p> <p>WILLIAMS advised she desired prosecution. I spoke to residents in apartment #4 and #11 who advised they did not see or hear anything unusual last night around the apartment building.</p> <p>Inv. Malloy and I attempted to speak to BLAIR, but there was no answer at the door. One of the other residents, however, advised BLAIR had been arrested last night by LPD. It was found that BLAIR was arrested at 0239 hours for intoxication after fight occurred in apartment 202 of 15601 Madison and police were called. BLAIR was released from LPD prior to this detail. Last nights incident is under CAD #081170035.</p> <p>BLAIR has a lengthy CCH that includes B&amp;E, Receiving Stolen Property, and Felony Drugs. BLAIR has an FBI #116275R5 and BCI #A845881.</p>
