Topic Original Report

MO: By slapping his ex-girlfriend, and mother of his child, in the face and knocking her to the ground, causing bruising to her face and a scratch to her chest.

MO: By dropping his pants and exposing his penis in an attempt to urinate on his ex-girlfriend's wig, incident occurred on a public sidewalk in view of others.

MO: By being voluntarily intoxicated, having a strong odor of alcoholic beverage on his breath, blood shot/glassy eyes and being involved in a domestic violence; all causing him to be a risk of harm to himself and others.

Lt. Warner, Sir:

On 4/26/08, at 1810 hours, INV WALLING, PTL ROBINSON, and I were detailed to Robin and Madison on a report of a male assaulting a female. The call came to dispatch from an anonymous female. On arrival, we observed a male yelling at a female in the rear parking lot of Bi-Rite. INV WALLING spoke to the male and I spoke to the female.

The female was identified as VIC/ . She advised the following: She stated that she was getting her hair done at a friend's house on Plover. She walked to the store with her friend, VIC/ JADELL BOWMAN. She was walking north on Robin to go to Bi-Rite. She stated that her ex-boyfriend, ARA/ ANTHONY MOODY, approached her from behind. He started yelling at her and BOWMAN, accusing her of having sex with BOWMAN. He then slapped her across the face, knocking her to the ground. She stated that he swung at her face numerous times and she tried to defend herself by blocking her face with her arms. She stated that he then pulled off her wig and threw it to the ground. He dropped his pants and exposed his penis in an attempt to urinate on the wig. She got up from the ground and walked to the rear of Bi-Rite, and that is when LPD arrived on scene.

In speaking with , I observed that she had a bloody scratch mark to her chest, redness and bruising under her left eye, and bruising under her chin. She declined medical treatment. She desires prosecution for domestic violence and she desires a TPO. She provided a written statement.

I spoke to BOWMAN and he advised the same as . He stated that he witnessed MOODY expose his penis in an attempt to urinate on wig. BOWMAN stated that MOODY was unable to urinate at that time, but advised that he would come back to, "piss on it later". BOWMAN advised that he desires prosecution for public indecency. BOWMAN provided a written statement.

It should be noted that there were numerous people on the porch of 2026 Robin where the incident took place. None of the people wanted to be identified and they all advised that they did not see anything.

MOODY was advised that he was under arrest for DV. He was secured in handcuffs and placed in the rear of unit #211. In speaking with MOODY, I detected a strong odor of alcoholic beverage on his

person, his eyes were blood shot and glassy, and his demeanor kept changing from cooperative to combative. He made numerous remarks of returning to residence when he got out of jail. He stated in the car, "Yeah, I slapped that bitch and I am going to do it again when I get out".

retrieved her wig. Since it was not urinated on, it was not taken as evidence. INV WALLING took photographs of injuries and the wig. She was provided with a City Resource Card.

I transported MOODY to the station. He was booked by CO BUNNER for DV, public indecency (M40681), and DCI(M40680). He was uncooperative at the booking window and would not provide booking information. He was secured in a cell.

It should be noted that MOODY has a CCH which includes priors for DV, aggravated arson, breaking and entering, menacing by stalking and burglary (FBI# [REDACTED] and BCI# [REDACTED]).

I called the Domestic Violence Center and advised Adkins of the incident. Lt WARNER made a copy of the DV call. It was tagged as evidence and secured in the property room in locker #18. A BCI form was completed and attached to this report.
