MO: Being in possession of 1.25 grams of marijuana in a plastic baggie.		
Sgt. Eschweiler, Sir:		
<p>While on patrol in the area of W.117th/Detroit, I observed the listed vehicle traveling at a high rate of speed S/B on W.117th. I paced the vehicle at 36mph. The windshield also had a large crack across it. The vehicle was stopped at the Max Pack parking lot, 11760 Berea on the W.117th driveway entrance.</p> <p>The driver was identified as SUB/HAKAM F. ABUAUN and the passenger was identified as ARA/JOSEPH P. KOLLAR. KOLLAR was not wearing his seatbelt at the time of the stop. ABUAUN was advised for the reason of the stop. ABUAUN advised he thought the speed limit was 35mph. ABUAUN did not have a reason for the windshield being cracked. Both ABUAUN and KOLLAR appeared to be nervous while I was speaking with them. I could observe ABUAUN and KOLLAR's hands shaking during the interview.</p> <p>While writing citations for ABUAUN and KOLLAR, I could see both males making movements towards the center console of the vehicle. I spoke to ABUAUN who advised I could search the vehicle. While searching the vehicle, Lt. Warner arrived to assist.</p> <p>In searching the vehicle, the listed marijuana was found in the ashtray of the vehicle. KOLLAR advised the marijuana was his. A further search of the vehicle for more drugs or contraband had negative results.</p>
