<p>MO: By having in his possession a small plastic baggie of marijuana.</p> <p>MO: By being voluntarily intoxicated, creating a risk of harm to himself and others due to his condition.</p> <p>On 4/27/08, at 0110 hrs., officers were detailed to 1328 Kenilworth on a complaint from COM/BRIAN KMATEOSKY stating there was a intoxicated male on his front porch. MATEOSKY further advised he did not know the male.</p> <p>On arrival, MATEOSKY pointed the male out to this officer. The male was walking up the driveway of 1327 Kenilworth. I approached the male and he identified himself as ARA/MICHAEL SALOPEK. While speaking with SALOPEK I could detect a strong odor of an alcoholic beverage coming from his person. I asked SALOPEK if he knew where he was. He stated he was on Northwood looking for his friends house. His speech was slurred, he was unsteady on his feet, and his eyes were bloodshot and glassy. Due to his condition SALOPEK was advised he was under arrest for DCI.</p> <p>During the search incident to arrest I located a small baggie of Marijuana in SALOPEK'S right front pocket. SALOPEK was transported to LPD in unit #221. SALOPEK was issued criminal citation #M40061 for drug abuse and M40062 for DCI and released to his father OIV/THOMAS SALOPEK. A Narco kit yielded positive results for Marijuana. The Marijuana was weighed tagged and placed down the chute in the property room.</p>
