Topic Original Report

M.O. - By punching victim about the head, with closed fists, causing physical harm to his face/nose.

On 4-28-08, at approximately 2133 hrs., officers were detailed to the area of Quail and Plover on the report of VIC/JAMES SEIDOWSKI having been beaten up by several other parties possibly living in the area. Prior to our arrival, dispatch advised that the other parties involved were approximately 10-12 black males who left the area toward Robin.

Upon arrival, officers began checking the area for the parties involved. Sgt. Kauchek, Sgt. L. Wilkins and I spoke with SEIDOWSKI and his friend, OIV/CHRISTOPHER DEAN. SEIDOWSKI's nose was bleeding and swollen on our arrival and looked as if it might be broken. He stated that he was beat up by several black males for no reason. He stated that he and DEAN and another male, he only knows as JASON, were hanging out in his garage listening to some music. While they were in the garage, a few juvenile females came to the door of the garage and SEIDOWSKI told them they had to leave. he told them that they were not allowed there. While SEIDOWSKI was telling them to leave, one of the females yelled, "my niggers are coming, my niggers are coming!" SEIDOWSKI stated that he only knew the first name of one of the females to be named

A short time later, several black males showed up at SEIDOWSKI's garage. When they arrived, he knew one of the males to be OIV/OMARK ROGERS. SEIDOWSKI shook ROGERS' hand and asked him what was going on. At that point, the other males with him began throwing chairs around inside the garage and one of the males punched SEIDOWSKI in the face. After he had been hit in the face, several other males also began hitting and punching him but he did not know any of the males who were hitting him.

The incident only lasted a short time before all of the males ran back to Robin where ROGERS lives. SEIDOWSKI contacted LPD a few moments later.

According to DEAN, he also only knew one of the females as . He stated that earlier in the day, they were hanging out and he let use his headphones to listen to some music. He did not know anything else and did not know why ROGERS and all the other males came to SEIDOWSKI's residence. He did not witness the actual Assault of SEIDOWSKI.

While speaking with DEAN, four females arrived at SEIDOWSKI's residence. They were identified as OIV/ P , OIV/ W , OIV/ I , and OIV/ S . SEIDOWSKI identified them as the females who were at his residence right before the fight.

According to the females, this fight was over some comment that was made between DEAN and some other male earlier in the evening. They did not believe the fight was going to take place, but came back to SEIDOWSKI's residence to see if everything was alright after they had heard a fight occurred. None of the females would give any more information about the situation.

After speaking with SEIDOWSKI, DEAN, and the four females, Ptl. Cantlin, Ptl. Hayes and I responded to ROGERS' residence to speak with him about the situation. According to ROGERS, SEIDOWSKI, DEAN, and P were at his residence earlier in the day hanging out with him. There was no fight or

argument of any kind during that time, according to ROGERS. Approximately an hour before the incident occurred, SEIDOWSKI, DEAN, and P all left ROGERS' residence. ROGERS denies being involved in any fight or altercation with SEIDOWSKI. He also stated that he has been home all night since they left his house. According to ROGERS, no one else had been at his residence since SEIDOWSKI, DEAN, and P left, except for OIV/DAMON KNOWLES who had just arrived at his residence.

KNOWLES also said he had just arrived at ROGERS' residence and knew nothing about any fight.

SEIDOWSKI was transported to Lakewood ER and was going to be treated by Dr. Rassmussen for the injuries he received to his nose.

Inv. Allen arrived and took photos of SEIDOWSKI's injuries.

SEIDOWSKI does desire prosecution in this matter and stated that he did not know who the males were that punched him, but he could identify them if he saw them again.
