Topic Original Report

MO/ By being in possession of a controlled substance, To Wit; Marijuana in an amount of 1.5 grams.

On 04-29-08, P.O. HARNER and I were detailed to assist Sgt. DONAHUE, DET. BUSI and other DB Personnel with the execution of felony warrants at 2104 Robin Avenue. Upon our arrival, several parties were found in the basement of the residence. The parties were secured and then patted down for weapons/contraband.

I patted down (ARJ) . During this, I located the listed baggie of marijuana in his left front pocket. Also found on was the listed \$155.00 in the same pocket. stated that the money was given to him by his grandmother, (OIV) WILLIAMS, JOHNNIE, to purchase some new shoes.

The items were confiscated and was released at the scene pending further follow-up by DET. BUSI. The narcotics were tagged and weighed with a gross weight of 1.5g. The currency was also tagged. The currency and narcotics were placed down the drug chute located in LPD's secured property room. The money was confiscated until 's story could be confirmed with JOHNNIE.

On 05/07/08, it was learned from Dets BUSI and FUERST that the money was going to be returned to the ARJs grandmother after being told to make arrangements through Property Room personnel. It should also be noted that after arrest, he was released to the custody of another grandparent per Det. BUSI.
