<p>MO-By entering the unlocked residence of the victim and cause damage to same without privilege to do so.</p> <p>Detailed on 4-30-08 at about 1610 hrs. on the report of a home entered by the complainants ex-boyfriend. On my arrival I spoke to VIC/KAREN SHEPHERD who advised the following.</p> <p>SHEPHERD stated that she has had numerous problems with her ex-boyfriend, SUS/ANTONIO SMITH, since they broke up. SHEPHERD was adamant that SMITH no longer lives with her. Further, SHEPHERD claims she has a TPO in effect at this time due to SMITH's prior Domestic Violence arrests with her being listed as the victim. In checking SMITH through LEADS, no TPO was found. SHEPHERD stated that she believes that SMITH is still on Probation through Lakewood Municipal Court but this was unable to be confirmed at the time of report.</p> <p>SHEPHERD stated that she was at work all day and when she returned home at about 1600 Hrs., found that her home had been entered. SHEPHERD stated that her dog was also missing from the home. Someone had apparently entered the home and poured a bottle of Pinnacle Cherry liquor all</p>

	<p>over her bed. SHEPHERD has since cleaned up the mess but prior to calling LPD for a report, began to check with any of her neighbors to see if anyone had seen SMITH hanging around. In speaking with OIV/JESSE SCALF, she found he had. SCALF stated that SMITH was observed hanging around the front yard of SHEPHERD's but he never saw him enter the residence. SCALF also never saw SMITH either let the dog out or take the dog with him from the area.</p> <p>SHEPHERD stated that she does wish prosecution in this matter. SHEPHERD stated that the likely point of entry would have been the unlocked front door. SHEPHERD stated that the home is actually her mother's</p> <p>SHEPHERD was advised on the report and to call back should SMITH be seen again tonight. SHEPHERD stated that the only reason she could see SMITH doing this is because he is angry that their relationship is "over".</p> <p>A short time after clearing this call, Dispatch received several calls about a dog running loose in the area of 1639 Winchester. In responding to that location it appeared that the dog in question was SHEPHERD's. SHEPHERD was then contacted and later responded to the scene to pick up the dog. The dog was in otherwise good shape and did not appear to have been abused in any way. SHEPHERD further advised that since this Officer left, SMITH had been calling her. SMITH was making "nonsense" when speaking with her. Also, SMITH denied being at SHEPHERD's home or otherwise causing any of the damage there. SHEPHERD had no other suspects in this matter.</p>
