Topic Original Report

MO: By punching the victim with a closed fist in the face causing a laceration to her forehead and bridge of her nose.

Lt. Warner, Sir:

On 5/2/08, at 0356 hours, PTL MULLEN, PTL GAMPFER, SGT. ESCHEILER, SGT. GANNON and I were detailed to 2120 Robin #2 on a report of a female assaulted by a male. On arrival I spoke to VIC/ and she advised the following: She stated that she was at 2126 Quail visiting a friend. She stated that SUS/ MARK BATES is a male that she is dating, but they do not live together. She stated that they got into an argument and she told him that she wanted a cell phone back that she had purchased for him. She said he got enraged and punched her in the face with a closed fist. She advised that she thinks he may have had the phone in his hand when he struck her.


had a laceration to her forehead and bridge of her nose. She advise that he only punched her one time. She advised that she desires prosecution. was dazed from the incident. She was not able to provide me with a written statement at the time. Squad One arrived on scene. was transported to Lakewood Hospital for treatment.

I responded to 2126 Quail and spoke to OIV/ PAMELA OUTLAW. She is the resident of this address. She advised the following: She stated that she is friends with and BATES. She stated that BATES has a girlfriend that he lives with at 12521 Plover to the rear. She stated that BATES is seeing behind his current girlfriend's back. She stated that they come to her house to be together. She stated that she was asleep when the incident happened. She heard BATES and yelling at each other and she came downstairs to find bleeding from the head. She stated that BATES had already left the residence.

We responded to 12521 Plover to check for BATES. He was not at that location either. We checked the area for BATES with negative results.

INV DEUCHER responded to the hospital to photograph injuries. She was being treated by Doctor Hastings:

It should be noted that BATES has a CCH which includes priors for Domestic Violence (FBI# [REDACTED] and no BCI#).
