Topic Original Report

MO: By pointing a handgun at one victims head, and a knife at another victims stomach, then grabbing the victim's purses in an attempt to steal them.

On 05/04/08 at 0245 hrs., I was responding to the area of 1612 Winchester to look for two Agg. Robbery suspects. I was driving south on Ridgewood Ave., approaching mid-block between Detroit Ave. and Franklin Ave., when I saw three people in the middle of the street. The three people were about three houses from me. As I approached, I saw a tall person, wearing a black hooded sweatshirt and dark pants, run west down the driveway of 1486 Ridgewood. Two females who were in the street, turned to my car and began yelling "Oh my God, thank God you're here. Two guys just tried to rob us. One had a gun and one had a knife". One of the females was crying hysterically. I notified the other cars in the area of what had happened and where the males were last seen running, then I began to check the immediate area for the suspects.

As INV FIORITTO responded to Alameda Ave., he saw two people matching the suspects descriptions in the area of 1486 Alameda. When the two people spotted INV FIORITTO's police vehicle, they ran back eastbound through the yards. A perimeter was established by the other available officers on duty between Lakewood Ave. and Alameda Ave. Officers searched the area for the suspects for about an hour, but had no success in locating them.

I responded to 1499 Ridgewood and spoke to (VIC)DANA BRADAGAN and (VIC)MARLENA MARCELLA. They advised that they left a party on Newman Ave. and walked north to Detroit Ave. They then walked west on Detroit Ave., then south on Ridgewood Ave. They walked down Detroit Ave. because they were going to split up at Ridgewood and walk home separately. BRADAGAN decided to drive MARCELLA home instead of the two of them walking alone, so they headed south on Ridgewood to get BRADAGAN's car.

They were walking on the east side of the street, and when they got to the area of 1486 Ridgewood, they began crossing the street toward 1494 where BRADAGAN's vehicle was parked. As they were crossing the street, the two suspect males were crossing the street, eastbound, right next to the females. Just after they crossed, the two males turned around and grabbed the females purses. The Hispanic male said "Give me your stuff" as he pointed a pocket knife at BRADAGAN and tried to pull her purse off of her shoulder. The white male pointed a handgun at the right side of MARCELLA's head and said "Give me your stuff, I don't want to hurt you sweetheart", as he was trying to get her purse off of her shoulder.

Immediately after trying to get the purses, one of the males spotted my patrol car headed south on Ridgewood and made a comment to suggest that the police are coming. The two males immediately released their hold of the purses and ran west down the driveway of 1486 Ridgewood. BRADAGAN and MARCELLA both stated that the entire incident could not have taken more than 5 seconds. It happened so fast, that they could not get a good look at the males faces, but the description they gave, matched the description of the two suspect males from the incident at 1612 Winchester (LK-08-003607).

Neither BRADAGAN nor MARCELLA had any injuries, they were just shaken and scared. They also stated that the two males were unsuccessful at getting any of their belongings. They do not recognize
