Topic Original Report

M.O. - By striking victim about the head and face with black handguns and taking victim's money.

On 5-4-08, at approximately 0237 hrs, officers were detailed to 1612 Winchester on the report of a male, who was bleeding, banging on COM/ JAMES LEGARTH's front door. LEGARTH advised dispatch that the male was yelling that he had just been beaten up and the males had guns.

Upon our arrival, Ptl. Cantlin, Ptl. Schad, and I located VIC/ GERALD MARKLEY lying face down on the front porch of 1612 Winchester. MARKLEY was bleeding from a cut on the back of his head and his left eye was bruised and swollen shut. At that time, MARKLEY stated that he was "pistol whipped" by two white males. He stated that they were both wearing black hooded sweatshirts and black pants. Both males had the hoods pulled up over their heads. He was able to see their faces and both males had facial hair. One male had a mustache and a goatee and the other had just a mustache. MARKLEY also stated that both males had black handguns. He stated they appeared to possibly be 45 caliber handguns.

This information was provided to the other officers in the area who were attempting to locate the suspects. Shortly after that, Ptl. Perhaps stated he was just stopped by two females on Ridgewood stating they had just been robbed by two males. In further speaking with the two females, the description appeared to be that of the two males who had just robbed MARKLEY a few minutes prior.

At that point, the two female victims stated that the males then ran W/B through the yards at 1486 Ridgewood. Officers then began to set up a perimeter in the area. Inv. Fioritto was driving N/B on Alameda from Franklin and observed two males matching the suspects description in the area of 1489 Alameda. When they saw him, they ran back E/B through the back yards. Officers continued checking the area and searching yards without success.

Squad 3 transported MARKLEY to the ER from 1612 Winchester. After searching for the suspects, Inv. Fioritto and I responded to the ER for photos and to further speak with MARKLEY. Inv. Fioritto took photos of MARKLEY's injuries and I obtained a statement of the incident from MARKLEY.

In further speaking with LEGARTH, he stated that he did not hear any of the altercation that had occurred. He said he only heard MARKLEY banging on the front door and yelling he had just been robbed. When LEGARTH looked outside, he only saw MARKLEY on his front porch bleeding. He did not see anyone else in the area or running from the area.

At that time, MARKLEY stated that he had left the bar and was walking home N/B on Winchester. As he walked down the street, the two suspects came "out of no where" and began beating him up with guns. He did not see where the males came from. MARKLEY stated he did not know the males and had not seen them prior to the incident. He said they continued "pistol whippin" him and reached into his pants pockets and took his twenty dollar bill. MARKLEY stated that he tried to fight them off, but was afraid of being shot. The males then left S/B toward Madison and MARKLEY then crawled onto the front porch of 1612 Winchester and began banging on the door for someone to call 911.

MARKLEY stated that prosecution is desired in this matter.
