Topic Original Report

MO/ By being in possession of a controlled substance To Wit; 1 oxycodone pill a schedule II narcotic

MO/ By being in possession of a controlled substance To Wit; 1 diazepam pill a schedule IV narcotic

MO/By obstructing or delaying the performance of a public official To Wit; failed to stop after being ordered to by police officers.

MO/ by being voluntarily intoxicated creating a risk of harm to himself, others, or property.

On 05-05-08 I was stopped by a pedestrian. The party advised that two intoxicated males were walking eastbound on Detroit in the area of St. Charles. The males were observed throwing items in the street and pushing over paper boxes. The pedestrian stated the males were last seen heading south on Belle.

When I turned onto Belle I observed a male riding the listed bicycle in circles on Belle in front of the Hospital entrance. The male on the bicycle was eventually identified as (ARA) KRUMPHANZL, PAUL. As I was pulling up to KRUMPHANZL he turned in front of my patrol car and was almost struck. The bicycle KRUMPHANZL was operating did not have a light. KRUMPHANZL turned into the drive of 1450 Belle where I observed a second male standing near the bushes. The second male was later identified as (ARA) TOMMER, JEFFERY. I exited my patrol car and ordered both males over to my car. TOMMER complied but KRUMPHANZL started riding off south on Belle.

KRUMPHANZL was ordered to stop several times but refused continuing south on Belle. The description of KRUMPHANZL was given out. P.O. HARNER, P.O. GREAR, P.O. HAYES and P.O. RODA arrived to assist in checking for KRUMPHANZL. KRUMPHANZL was arrested by P.O. HARNER and P.O. HAYES at 1515 Marlowe.

In speaking with TOMMER he first denied being on Detroit or being with KRUMPHANZL. TOMMER eventually admitted to being on Detroit but claimed he never threw anything or knocked over a paper box. TOMMER stated he was attempting to clean-up the items. Prior to knowing KRUMPHANZL's name TOMMER was asked about who was on the bicycle. TOMMER claimed it was a male he met in the bar tonight and he only knew him by "FRED". TOMMER maintained that he did not know KRUMPHANZL.

Dispatch contacted TOMMER's wife (OIV) MATTHEWS, JOCELYN. MATTHEWS responded to the scene and took custody of TOMMER. TOMMER was issued citation M40651 for DCI. In checking the area I located the bicycle KRUMPHANZL was riding. The bicycle was found on the sidewalk in front of 1487 Belle.

The bicycle was taken back to the station where it was tagged and placed in LPD's secured property room. I also tagged the listed pills recovered by P.O. HAYES and P.O. HARNER. The pills were placed down the chute located in LPD's secured property room. The computer and bike board both checked NIF for the bicycle.
