

	<p>MO: By using physical force to push in front door, taking listed coins from bedroom dresser and phone from kitchen counter without owners permission.</p> <p>On 5-6-08, at 1658 hrs., INV. KULCZYCKI and I were detailed to 11835 Lake #4 on the report of an apartment entered. On arrival, I spoke with VIC/CRAIG BOBBY, who said he came home from work this afternoon and found his front door had been forced open.</p> <p>BOBBY said he is only missing some rolled pennies and a roll of quarters from his dresser drawer in his bedroom. BOBBY said a few things in the bedroom had been rifled through but nothing else appeared to be taken.</p> <p>BOBBY said his cordless phone was taken from the kitchen and that was all that he noticed missing.</p> <p>It appeared the suspect(s) used physical force to defeat the wood door that was locked with a deadbolt. The door jamb was completely broken, which allowed access into the apartment.</p> <p>I knocked on BOBBY's neighbors door at #3 and nobody was home. I checked with # 1 and #2, no answer and the doors were all locked (all on first floor).</p> <p>BOBBY has no suspect(s). I advised BOBBY of the low solvability factors of this report. However, BOBBY said if a suspect(s) were located he would prosecute in this matter.</p>
