Topic Original Report

MO: By entering apartment by unknown means, and removing listed currency from purse on end table without owners permission.

On 5-5-08, at 0905 hrs., I was detailed to 1345 Bunts on the report of money stolen out of a purse in apartment #207. On arrival, I spoke with VIC/FLORE KYRITSIS, who said she had \$260.00 in her purse on an end table on 5-2-08. KYRITSIS said \$238.00 of the money was for her rent.

KYRITSIS said a neighbor asked her to go to the store on 5-2-08 at approximately 1520 hrs. KYRITSIS said she did not take her purse because she was just going along for a ride. KYRITSIS said when she went outside to the parking lot, she saw Health Aid worker, SUB/BRANDY HUFSTETLER in the parking lot and said hello to her. KYRITSIS then went to the store with her friend.

KYRITSIS said she came back home about an hour or so later. KYRITSIS said she put her key in the door lock and noticed that her door was not locked. KYRITSIS did not think anything of this and just went on about her daily routine. KYRITSIS is unsure if she locked her door.

KYRITSIS said on 5-4-08, at approximately 1400 hrs., she went shopping with another friend. KYRITSIS said when she went to pay for her item, she noticed her money was missing from her purse.

KYRITSIS said she spoke with Lakewood Senior Health Campus Director, OIV/TAMMY SIBERT in the office on 5-5-08 and was advised to make a police report on this incident.

I spoke with SIBERT, and she advised me that numerous workers have master keys to all apartments there. I advised her that KYRITSIS knows that HUFSTETLER saw her leave on 5-2-08 in the afternoon and knew she was not home. KYRITSIS said that HUFSTETLER knows she lives alone.

SIBERT said HUFSTETLER has not been accused of stealing or anything like this in the past.

INV. WALLING was at the scene, he advised me that nothing of value was located.

I advised KYRITSIS of the low solvability factors of this report. However, KYRITSIS said if a suspect(s) is located she would prosecute in this matter.

The only resident that would have a clear view of KYRITSIS's apartment lives directly opposite her in apartment #206. I knocked on the door but there was no answer.
