	<p>M.O.: By breaking a glass window to the rear door, entering the residence and taking the victims cell phone, without the owners knowledge or consent.</p> <p>M.O.: By breaking the vehicle's windows without the owners knowledge or consent.</p> <p>On 5/7/08, at 0235 Hrs, I responded to 1567 Victoria. COM/JASON NOVICKY stated he observed a black male, wearing a red t-shirt and dark pants, break out the car windows to his neighbors vehicle. NOVICKY stated the vehicle was parked in the driveway directly north of his residence. Dispatch advised NOVICKY waited approximately twenty minutes before contacting the police.</p> <p>When I arrived on scene, I observed the listed Ford parked in the driveway of 1563 Victoria. The rear window, and four side windows, were completely shattered. Glass was both inside the vehicle and on the ground. The front windshield had a large circular spiderweb pattern in the center of the windshield. The right front door was ajar, and a rock was observed on the drivers seat. Officer Mullen arrived to assist.</p> <p>I spoke with NOVICKY and learned the following:</p> <p>NOVICKY indicated he was inside his residence when he heard a noise outside. When he looked out</p>

his window, he observed a tall black male with a medium build break out the car windows. NOVICKY stated the male was wearing a red t-shirt and dark colored pants. NOVICKY stated he recognized the male from prior incidents at the residence. He was unsure of the male's name, but stated he believes it was the suspect from a GTMV report that was taken in April, #08-002573. The GTMV report lists SUS/THEODORE ROULETTE as the suspect.

I attempted to contact the owner of the vehicle, VIC/HEATHER LAUERSDORF, but was unsuccessful. There was no answer at the door or by phone. We cleared the scene at this time until we were able to contact her.

On 5/7/08, at 0434 Hrs, Inv. Register and I responded to 1563 Victoria. LAUERSDORF called to inform us her house had been broken into and her vehicle was damaged sometime overnight. When I arrived on scene I spoke with LAUERSDORF and OIV/JASON KAYE and learned the following:

LAUERSDORF stated she believes the male she is seeing, ROULETTE, damaged her vehicle and broke into her residence. LAUERSDORF was working at McGinty's on the evening of 5/6/08 when she and ROULETTE got into a verbal altercation. LAUERSDORF stated he was upset because he thought she was ignoring him throughout the evening. While arguing outside, her friend KAYE approached them. KAYE was worried about LAUERSDORF because he has seen ROULETTE lose his temper and become violent in the past. When ROULETTE realized KAYE was not leaving, he left angry and walked to the Richland Cafe.

KAYE stated because ROULETTE was angry, he made sure LAUERSDORF got home safely. While they were at LAUERSDORF's residence, ROULETTE called. He was telling LAUERSDORF to leave her back door unlocked. LAUERSDORF told him she did not want him to come over because he was angry, and that they would talk later. KAYE did not feel comfortable leaving LAUERSDORF home alone, so they decided to go to his house. KAYE stated they left LAUERSDORF's residence at approximately 0140 hrs. LAUERSDORF locked her doors and left her cell phone on the dining room table.

At 0238 hrs, KAYE received a phone call from LAUERSDORF's cell phone. When he answered the call, ROULETTE was on the line and asked him if there were any girls at his house. KAYE hung up on ROULETTE.

KAYE brought LAUERSDORF back to her house at approximately 0434 hrs. When they arrived, they saw the damage to her vehicle and found the interior of the house in disarray. They contacted the police immediately. KAYE and LAUERSDORF indicated ROULETTE was wearing a red t-shirt and black slacks this evening.

LAUERSDORF's residence is a multiple dwelling unit. LAUERSDORF lives downstairs. There is an enclosed porch located on the eastside of the house. There are two doors that access LAUERSDORF residence from the porch. The north door has 10 glass panes. The middle pane closest to the door lock was broken, allowing access to unlock the door. This rear door was slightly ajar and there was blood smeared on the exterior of the house. This door leads to LAUERSDORF's bedroom. Shattered glass was scattered on the floor. Several personal items were thrown around the room. LAUERSDORF's computer and computer monitor was thrown to the floor off a desk located in the dining room. Several other items were also thrown on the floor. Her cell phone was stolen off of the dining room table. Inv.
