N A R R A T I V E  1	Topic	Original Report
<p>MO/ Did obstruct or delay the performance of a public official in the performance of his duties, To Wit: Fled on foot after being instructed by officers several times to stop.</p> <p>On 05-08-08 P.O. GREEAR, P.O. CANTLIN and I were detailed to the Richland Cafe. Dispatch received a call from (COM) KAYE, JASON. KAYE advised that (ARA) ROULETTE, THEODORE was in the bar. ROULETTE was a suspect in a burglary that occurred in Lakewood report #08-003694. Dispatch advised that there was an active warrant for his arrest for that burglary. KAYE reported that ROULETTE was wearing a black jacket with white writing on the back and dark colored pants.</p> <p>As I was approaching the bar I observed P.O. GREEAR and P.O. CANTLIN walking westbound towards the bar. A male then exited from the alley west of Sunoco. A party in front of the bar pointed to the male that came from the alley and stated it was ROULETTE. ROULETTE was wearing jeans and a black jacket with a white "R" on the back. As we started towards ROULETTE, he was already in the lot of Sunoco. ROULETTE then looked back and observed officers coming towards him and he started running. ROULETTE was ordered several times to stop running but he did not comply.</p> <p>ROULETTE ran south on Bunts then west through the backyards. Officers lost ROULETTE in the area between Bunts and Richland. A perimeter was set-up and P.O. OBROCK was called in to assist with the search. After searching the area for quite some time, P.O. HAYES advised that he observed a male on the west side of Brown walking north towards Madison. As P.O. HAYES approached the male, the male started running. The male crossed Madison at which time P.O. RUSNAK was able to apprehend him. The male was identified as ROULETTE.</p> <p>ROULETTE no longer was wearing his jacket and was missing a shoe. ROULETTE denied ever having a jacket and refused to cooperate with officers. In checking the yards, ROULETTE's shoe was located in the backyard of 2030 Bunts. Officers were unable to locate ROULETTE's jacket.</p> <p>P.O. RUSNAK transported ROULETTE to the station. ROULETTE was booked by P.O. PERHACS. ROULETTE was booked for the burglary warrant and Obstructing Official Business. ROULETTE was issued citation M40653 for the obstructing charge.</p>
