Topic Original Report

MO1: By cutting the rear window screen, opening the unlocked window, entering 1502 W. 117th St. #16, and taking the victim's computer without permission or consent.

LT. SPRAGUE, Sir:

On 5-8-08 at 0938 hrs. officers were detailed to 1502 W.117th St. on the report of the complainant's apartment having been broken into and his computer stolen.

On arrival I spoke with VIC/JEFFREY ROZIER and his girlfriend, OIV/CATHERINE HERNON. ROZIER stated that HERNON had spent the night at his apartment and he left for work at 0515 hrs. ROZIER added that he works Tuesday through Friday and leaves at about 0515 each day he works. HERNON stated that at about 0615 hrs. she heard a knock at ROZIER's apartment front door. She yelled "who is it," and there was no answer. HERNON stated that there was another knock at the front door at about 0630 hrs. When no one answered HERNON when asked who it was she called ROZIER regarding the knocks. ROZIER spoke with HERNON and they decided not to call LPD. HERNON stated that she left to go to CSU at 0730 hrs. She returned to ROZIER's apartment at approximately 0900 hrs. When HERNON walked in, she immediately noticed that the listed computer and components were missing. These items are usually kept on the east wall of the apartment just south of the front door. As she entered the apartment, she observed ROZIER's other computer and components on the floor in front of the rear west window. In checking the window, it was unlocked, closed, and the screen had been cut. HERNON checked the bedroom and found that some dresser drawers and her make-up bag been gone through. Nothing appeared to be missing from the bedroom. HERNON called ROZIER and he responded to his apartment. On arrival he called LPD.

ROZIER stated that the listed computer and it's listed components had been kept on a desk on the east wall of the living room. Found in front of the west window were an Acer computer, an Eworks CD burner, an Acer 15" flat screen monitor, an Arris cable modem, a Saitek key board, and a Saitek mouse. ROZIER added that these items had previously been in the area of the stolen computer.

Along the living room's west wall are two windows. Both windows are 5' 3" from the sidewalk outside. The screen on the southern most window had been cut on three sides. ROZIER stated that he did not believe these windows were left locked. It is believed that the suspect(s) cut the screen and entered the apartment. Once in the apartment the suspect(s) took the listed computer and components out the same window they entered. Additionally, the other computer and components were left near the window. Most likely the suspect(s) were interrupted during the theft and unable to leave with the other items.

INV. GEARY #71 responded and processed the scene. Photos were taken but no latents were obtained.

When asked regarding suspects, neither ROZIER or HERNON could specifically name any particular suspects. However, they both advised that recently they have noticed two young, adult, black males who have been hanging around the apartment complex. They do not believe the males live in the complex and they think that they repeatedly visit a party at 1500 W. 117th St. #11. HERNON stated that she has seen these males repeatedly looking into parked vehicles and acting suspicious. ROZIER

stated prosecution was desired, he was advised of solvability.

In checking the area to the rear of the complex I noticed that the screen to another apartment had been cut in the same fashion as ROZIER's apartment window. Due to the location of the window, it was unclear whether it belonged to apartment #11 or #14 at 1500 W. 117th St. I knocked at #14 and there was no answer. I then knocked on #11 and there was no answer either. However, as I was walking away from #11, I observed two males walking through the parking lot approaching #11. I asked these males where they were going. They stated to their friend's apartment, #11. The males were identified as SUS/JULIAN GILL and his brother, SUS/ . JULIAN stated that he and stayed at their friend's apartment, SUS/ADAM FERGUSON, last night. JULIAN advised that he and left from the apartment at 0700 hrs. and went to put in job applications. When they left, FERGUSON was still in the apartment. They were just returning when I stopped them. I asked JULIAN where FERGUSON was and he stated "at work". JULIAN refused to tell me where FERGUSON worked. Neither JULIAN nor were very forthcoming regarding MIN information. JULIAN asked me why I needed this information and I told him that a couple apartments had been broken into through the back windows and I was just doing some follow up investigation. JULIAN then stated that #11 was not broken into and that the rear window screen had been damaged a few months ago by FERGUSON when he was locked out of his apartment. I asked JULIAN if he had ever been arrested and he stated "not for Burglary." JULIAN stated that neither he nor know anything about any burglaries.

It should be noted that in running JULIAN he does have a CCH with a BCI number of an FBI number of and an LPD number of . Further that JULIAN was arrested for AGGRAVATED BURGLARY by LPD on 9-25-07. Additionally, JULIAN stated that he resides at the listed address. In speaking with staff from the Youth Re-Entry program at 11849 Clifton Blvd., they advised that JULIAN had been removed from the program about two and a half months ago. Also, FERGUSON has a CCH with a BCI number of and an FBI number of .
