Topic Original Report

M01: By forcing the front door at 2167 Chesterland Ave., entering the residence and removing the copper pipes from the basement.

LT. SPRAGUE, Sir:

On 5-8-08 at 1205 hrs. officers were detailed to 2167 Chesterland Ave. on the report of the front door having been forced open.

On arrival officers spoke with VIC/ MARC STRATTON. STRATTON stated that on today's date at approximately 1200 hrs., he stopped to check on his property at 2167 Chesterland Ave. When he arrived, he noticed that the front door was partially open. Closer inspection showed that the door had been forced open.

2167 Chesterland Ave. is on the east side of the street. The front door faces west towards Chesterland Ave. and the side door faces north towards the driveway. The front door appeared to have been kicked with enough force to splinter the door around the door handle and knock the latch from the handle. In checking the basement, all of the copper pipe running from the two hot water tanks to the upstairs had been cut and removed. It appears that the pipes had been cut with a pair of hand clippers as the ends of the remaining pieces of copper were found pinched together. In further checking the basement, the listed hedge clippers were found on the floor just north of the stairs. I asked STRATTON if the clippers belong to him and he stated "no". The clippers were subsequently confiscated, tagged, and secured in the LPD Property Room.

STRATTON stated that he had last been at the property on 4-26-08, but his realtor OIV/ANNE CALLAHAN has been showing the house. I had dispatch contact CALLAHAN via telephone. CALLAHAN advised that OIV/ALICIA PHILIPPS had shown the house around 1100 hrs. on 5-3-08 and the house was undamaged at that time.

INV. GEARY #71 processed the house. Photos were taken, no latents were obtained.

In canvassing the area, officers spoke with Michael Zorich at 2165 Chesterland Ave. He advised that he had seen a realtor at the property the previous weekend, but no one unusual or suspicious. Officers were unable to reach any of the other neighbors.

STRATTON stated that he does have insurance on the property, but he is unsure of the name of his insurance provider. Additionally, he stated that prosecution is desired although he does not have any suspects. STRATTON was advised of solvability factors.
