Topic Original Report

SGT Favre, Sir,

On patrol on 5/9/2008 at 1815hrs. Flagged down by COM/MELISSA SCOTT on Madison near Lincoln. MELISSA stated that at 1500hrs on the day of this report her son, SUB/DAVID SCOTT, broke into her apartment and stole 4 DVDs (Rocky Balboa, Harry Potter, Spiderman 3, Ocean's 13) and a CD (Day 26 - self titled). MELISSA claims that DAVID has not lived at the apartment for "a few months" and that he does not have permission to be there, although DAVID still has property there and receives his mail at that address. MELISSA arrived home to find DAVID inside the apartment at 1681 Lincoln (# 5). DAVID has a key to the apartment in which MELISSA claims he should not have, which is how he entered. MELISSA claims that she saw DAVID with the listed DVDs in his hands. DAVID ran out of the back door on her arrival. MELISSA advised that DAVID may be with friends in the Birdtown area.

I looked for and found DAVID walking on Lark near Thrush. DAVID did not have the listed items on his person. DAVID denied being at the apartment on the day of this report. However, DAVID advised that he still lives at the residence and is there frequently with MELISSA'S consent. DAVID does have a key to the apartment, but claims that MELISSA gave it to him. DAVID confirmed that he still has property at the apartment and that he still receives his mail there. DAVID advised that he does not have an alternate home of record. DAVID was advised and released at the scene.

I went back to 1681 Lincoln #5 and explained my conversation with DAVID to MELISSA. MELISSA was informed that this incident may be a civil matter if DAVID is found to be a resident at 1681 Lincoln #5. MELISSA was advised of the eviction process.
