Topic

MO: By entering an apartment of a person unknown to him, through an unlocked front door and stumbling over a person that was sleeping in a chair, then causing alarm to the female resident who woke up to find him sleeping on the floor in front of her bedroom.

5-10-08 at 0705 hrs, Inv. Malloy and I were detailed to 18239 Sloane #3 on report that a female resident had awoken to find a male sleeping on the floor in front of her bedroom door. She stated that the male was a hispanic male with a dark leather jacket. Upon arrival, the resident stated that the male had left her apartment and was getting into a red pick up truck that was parked in the rear lot.

We went around to the rear of the building and found ARA/ PAUL RODRIGUEZ in the listed red pick up. He was escorted from the truck and secured in handcuffs and placed in the rear of car 205. Inv. Malloy went and spoke to VIC/ LAURA COUSINO who reported the following. LAURA stated that she went out the night before with friends and her ex- husband, OIV/ JONATHAN COUSINO, was babysitting their two children ages 1 & 3 until she arrived home at 0200 hrs. JONATHAN left the residence at approx 0515 hrs and RODRIGUEZ was not in the apartment at that time. LAURA stated that she woke up at approx 0700 hrs and found RODRIGUEZ sleeping on the floor in front of her bedroom door. It was learned that she was able to wake RODRIGUEZ up and told him that if he did not leave she was going to call the police. RODRIGUEZ was refusing to leave and that's when she called the police. LAURA stated that she found the kitchen window open after the male left and stated that it was not that way when she arrived home.

RODRIGUEZ was transported to the station and booked in by CO. BUNNER. He kept saying that he was at his brother's resident, but stated that he could not remember what apartment or a phone number for him. He was advised that he was not in his brother's apartment but was in a female's apartment with her two children. He had a faint odor of an alcoholic beverage about his person but did not appear to be intoxicated. He was booked in for burglary and found to be on parole. His PO is Elizabeth Wyant at 615 Superior Ave. #960 and the phone number is 216- . I called his PO and left a message on her voice mail about RODRIGUEZ's arrest. Also, located in his wallet was a West Side Metals scrap ID card # 13799 with RODRIGUEZ's photograph on the back.

At the booking window he was able to remember a phone number for his brother and another person that he called. He stated that he could not remember his address but stated that he lived on Vega in Cleveland. He also stated that he could not remember his place of employment. He stated that he just got out of prison and can't remember the address where he lives. On one of his phone calls he told the person what he was arrested for and stated " Louie, I fucked up, I should've listened to you, but I gotta do what I gotta do". The phone number he called for this person was 216-

RODRIGUEZ has a CCH and was found to be BCI # B171371 and FBI # 612556EA6. His listed vehicle was towed to Kufner.

Later, Inv. Malloy was able to make contact with LAURA's ex- husband JONATHAN. He confirmed that he left the residence about 0515 hrs and that he did not know RODRIGUEZ. He did stated that there was a loud party somewhere in the building last night.

I later spoke to Det. Motylewski who advised that during a follow-up investigation, RODRIGUEZ was at

[REDACTED] the party that was in the building. It was learned that his brother did live in the apartment where the party occurred. Apparently when JONATHAN left the residence this morning he left the front door unlocked, and shortly thereafter, RODRIGUEZ walked in the door and stumbled over LAURA'S cousin, OIVI [REDACTED], who was sleeping on a chair in the living room. [REDACTED] thought that RODRIGUEZ was a friend of LAURA'S and didn't think anything more about it.

RODRIGUEZ went and used the bathroom and then sat in a chair. RODRIGUEZ fell out of the chair and landed on the floor by LAURA'S bedroom where he remained until LAURA woke up and found him. Due to this new information RODRIGUEZ was charged with Disorderly Conduct (509.03 A5) and a citation was issued.
