Topic Original Report

MO- By kicking in the front door of the residence and taking copper pipe from the basement without permission to do so.

On 5/10/08, at 2013 hours, officers were detailed to 2123 Waterbury on a report of copper pipes being stolen from the basement. Upon arrival I was met by VIC/TED UEHLINGER. UEHLINGER stated he had just bought the house and was fixing it up. UEHLINGER said that prior to today he was last in the house a week ago.

UEHLINGER took me inside and showed me the front door. The door had been kicked open with damage done to the door jamb. Once downstairs we observed the pipes between the south wall and the hot water tank had been cut. All the pipe that was supposed to be in the ceiling was gone. There was approximately 10 feet of pipe taken.

Inv. Register arrived on scene, took photographs, and processed the area (see his supplemental for further details). I then canvassed the neighborhood speaking to both neighbors as well as a number of area kids. No one reported seeing or hearing anything of evidentiary value. UEHLINGER has no suspects in this matter but desires prosecution if possible.
