Topic Original Report

MO: By forcing their way into victims apartment and knocking him down, hitting him with a open hand, and with a wooden stick, inflicting physical harm on victim.

MO: By resisting officers attempt to arrest him.

MO: By being voluntarily intoxicated creating a risk of harm to themselves and others due to their condition.

On 5/11/08, at 0006 Hrs., Officers were detailed to 2196 Atkins, on a complaint from VIC/CHRISTOPHER DEMARCO, sating his downstairs neighbors broke into his house and assaulted him. On arrival, INV. MLADEK and I spoke with DEMARCO, and he advised the following. He heard a knock on his apartment door. He asked who it was, and he heard ARA/JENNIFER MAYER, and ARA/MELISSA HAAS, state "open the door we have someone to kick your ass". DEMARCO told them to go away. DEMARCO said MAYER, HAAS, and ARA/JEFFREY HOLMES forced their way into his apartment. The house is a three story multiple dwelling home with a residence on each floor. DEMARCO resides on the third floor and MAYER resides on the first floor.

While in the apartment MAYER hit him in the face with her open hand and knocked him down. DEMARCO stated HOLMES picked up a piece of wood from the broken door jamb and struck him with it. DEMARCO said he was struck in the right hand. He had a visible laceration on the knuckle area of his right hand. He advised that HAAS entered his apartment but did not assault him. DEMARCO stated he told them he was going to call the police and they left. DEMARCO said he did not desire medical attention to treat his injury.

DEMARCO advised, his apartment door was secured with a rope tied from the doorknob to the railing. He said the lock on his apartment door has been broken for about two months. The door opened outward and the door jamb was damaged. DEMARCO showed me the piece of wooden door jam that HOLMES allegedly struck him with. He further advised he would have been struck in the head with the wood if he hadn't put his hand up to protect himself. DEMARCO stated he desires prosecution and provided a written statement. DEMARCO stated that he and MAYER were friends. He stated he only knew HAAS and HOLMES from seeing them with MAYER. He said he did not know what provoked the incident.

INV. MLADEK and I attempted to get MAYER, HAAS, and HOLMES to come out and speak with us. All three of them initially would not come out of the house. After several minutes of talking through the door and windows HOLMES exited the front door and started walking toward the listed Ford Mustang parked at the end of the driveway blocking the sidewalk. INV. MLADEK and I approached him, and advised him to put his hands behind his back. HOLMES refused. I advised him, he was under arrest for Aggravated Burglary, and to put his hands behind his back. HOLMES said "Bullshit" and attempted to pull away from officers. HOLMES was assisted to the ground by INV. MLADEK and I. After a brief struggle, and being told several times to stop resisting, officers were able to secure HOLMES in handcuffs. He was secured in the back of unit # 216. I advised HOLMES of his Miranda rights. The only statement he made to me is "this is bullshit".

I went to the back of the house and HAAS was standing in the back hallway. I advised her she was

under arrest for Aggravated Burglary. She was secured by this officer without incident. I could detect a strong odor of an alcoholic beverage coming from HAAS'S person. She was unsteady on her feet, her eyes were bloodshot and glassy. Her speech was also slurred. HAAS was advised her Miranda rights. She stated she went up to DEMARCO'S apartment with MAYER and HOLMES but she didn't do anything wrong. She was secured in the back of unit # 213.

SGT. GANNON and PO GAMPFER arrived assist. Officers continued to attempt to get MAYER to come out of the apartment. After several warnings, and because of the nature of the offense, the decision was made to force entry to arrest MAYER. I forced the rear door opened. The door entered into the kitchen. MAYER was standing in the kitchen and was taken into custody. She was advised she was under arrest for Aggravated Burglary. MAYER was advised her Miranda rights. She refused to say anything about the incident. I could detect a strong odor of a alcoholic beverage coming from her person. she was unsteady on her feet and her eyes were blood shot and glassy. Her speech was also slurred. She was also secured in unit #213.

HOLMES was transported to LPD by PO GAMPFER, and booked in by her and PO DE. MCCARTHY for Aggravated Burglary and Resiting arrest. HOLMES has a CCH FBI#93015R3 and BCI#A851489 for Criminal Trespassing, Stong arm Robbery, Robbery, Assault, and Public Indecency. The listed vehicle HOLMES was attempting to get into belongs to OWN/ALAN THOMPSON and was towed incident to arrest by Kufner Towing to be held for him.

HAAS and MAYER were transported to LPD by this officer. HAAS was booked in by PO. GAMPFER and PO DE. MCCARTHY for Aggravated Burglary and DCI. MAYER was booked in by PO MCCARTHY, Dispatcher Nickler, and myself for Aggravated burglary, DCI, and Warrant other PD. The warrant is for Contempt of Court out of GOV/CLEVELAND PD and was confirmed by Sgt. Dennis and he placed a holder. MAYER has a CCH FBI# _____ and BCI# _____ for Aggravated Burglary, Escape, Burglary, Felonious assault, resisting arrest, Felony Drug possession, and OVI.

INV. MLADEK took photos of DEMARCO'S injuries and the damage to his door. He also processed the piece of door jamb HOLMES allegedly struck him with. The piece of wood was tagged as evidence and secured in the property room. INV. MLADEK also took photos of MAYER'S door that was damaged when officers forced entry. The door jamb where the dead bolt latches was damaged. The Latch was pushed away from the door jamb but did not fall all the way out. The top panel of the door was also damaged. I left a message with OWN/KENNETH HANNA regarding the damaged door. MAYER'S door was secured by INV. MLADEK prior to leaving the scene.
