Topic Original Report

- M.O. By pushing and eventually forcing the front door to the victim's residence to gain entry without the owner's permission to do so and then assaulting victim.
- M.O. By grabbing hold and pushing the mother of his child to the ground causing physical harm.
- M.O. By punching the victim in the face multiple times with his fist.
- M.O. By throwing a punch at the victim in an attempt to cause physical harm.
- M.O. By violating a Temporary Protection Order, signed by a judge, by entering the victim's residence and having contact with the victim.
- M.O. By having three 5" steak knives in the center console of his vehicle that were accessible to him.

On 5-14-08, at 0226 hours, P.O. CANTLIN and I were detailed to the intersection of Hilliard and Victoria regarding parties outside fighting. Upon arrival I saw three females and two males who were arguing and yelling. Myself and P.O. CANTLIN separated the parties and talked to each person regarding the incident and learned the following.

On 5-13-08, Officers were detailed to the same address regarding a male who kicked in the door of his ex-girlfriends residence, see P.O. RODA'S report, #08-003900 for details. The first party I spoke with was ARA/CHAD COLON, who stated the following. COLON stated his ex-girlfriend, VIC/LEANDRA BALLOG, had called him and told him to come over. COLON and LEANDRA have a child together, OIV/ . COLON stated himself and his cousin, ARA/SHAWN MELNIKAS, and OIV/JESSICA GUS, were walking up to the house when LEANDRA'S sister, VIC/RACHEL BALLOG, and LEANDRA approached him and began yelling at him. COLON stated the got into an argument but did nothing wrong. COLON kept stating that LEANDRA was the one calling him. COLON stated he went to the residence when he knew LEANDRA had a Temporary Protection Order against him but he stated he wanted to see his kid.

Myself and P.O. CANTLIN then spoke to LEANDRA and RACHEL and learned the following. RACHEL stated that her sister LEANDRA called her over because she was scared her ex-boyfriend was going to come over to the house and he is violent. RACHEL stated she pulled into the driveway and when she exited her vehicle she saw COLON, MELNIKAS, and GUS approaching the house. RACHEL stated she ran to her sisters residence to tell her sister that COLON was coming to the house. RACHEL stated she was trying to hold the front door closed but it would not lock due to the damage done to it the day before. RACHEL stated that COLON and MELNIKAS were pushing the door and were trying to gain entry into the residence. RACHEL stated that they were able to get through the door and were walking up the stairs attempting to contact LEANDRA. RACHEL stated LEANDRA came down the stairs and told them to leave because the police were on the way. RACHEL stated that COLON and MELNIKAS then left and went outside. While outside, RACHEL stated that COLON and MELNIKAS were yelling and screaming at LEANDRA. RACHEL stated she tried to keep COLON away from LEANDRA and COLON then punched her in the face three times. RACHEL stated that MELNIKAS also tried punching her once. RACHEL stated she fell to the ground and saw COLON grab LEANDRA and throw her to the ground. RACHEL stated she got to her feet and then the police arrived. I took a statement from RACHEL and she desires prosecution. P.O. GREEAR responded and took photos of RACHEL'S injuries. RACHEL had some red marks and a bump on her face. RACHEL stated she did not need any medical treatment.

P.O. CANTLIN took a statement from LEANDRA from this incident. LEANDRA stated that COLON and MELNIKAS forced their way into her residence. LEANDRA stated that after they left the residence they went outside. While they were outside she saw COLON punch RACHEL several times and then COLON grabbed LEANDRA and pushed her to the ground. LEANDRA stated she desires prosecution in this matter and did not want medical attention. LEANDRA was provided a resource card.

I spoke with MELNIKAS and GUS about the matter. MELNIKAS stated that COLON picked them up from the bar and they went to LEANDRA'S house to retrieve some of COLON'S property. MELNIKAS stated that they tried to go into the house but RACHEL would not let them inside. MELNIKAS stated they tried walking away but they got into an argument and then the police arrived. GUS stated she was waiting outside because she only knows MELNIKAS and not the other parties. While speaking with RACHEL and LEANDRA, MELNIKAS went to COLON'S vehicle and began to back into a drive and drive away. MELNIKAS was told to park the vehicle and not leave the scene by this officer. MELNIKAS is currently under a Failure to Reinstate Suspension. MELNIKAS was not driving due to an emergency. MELNIKAS did not have a driver's license on his person. He was later issued citation# D161174 for DUS. The vehicle was towed to Kufner Towing. During the inventory search of the vehicle, P.O. GREEAR located three black handled steak knives in the center console of the vehicle which is owned by COLON. Also a camcorder was found in the vehicle and was taken to be held for the owner. COLON was advised he would also be charged with Unlawful Transactions in Weapons.

COLON was transported to LPD where he booked in by P.O. PERHACS, P.O. CANTLIN and myself for Agg. Burglary, Domestic Violence, Assault, TPO violation, and Unlawful Transactions in Weapons. MELNIKAS was transported and also booked in by P.O. PERHACS and I for Agg. Burglary, Assault and DUS.

The knives and camera from the vehicle were tagged and placed in locker #23 of LPD'S secured storage room. The right shoe that belongs to COLON was also tagged and placed in locker #23 of LPD'S secured storage room. On 5-13-08, INV.FIORITTO took a shoe print that was found on the door that was kicked in at 14938 Hilliard. The shoe print COLON was wearing matched the same shoe print that INV.FIORITTO obtained from the damaged door.

I spoke with Elvira at the Domestic Violence Center and reported the incident. I spoke with Tyson at 696-KIDS and she provided me with an incident number of 473017. I spoke with Kimberly at Children Who Witnessed Violence and reported the incident.
