Topic Original Report

MO:By concealing 3 bottles of scented oil in her pocket and trying to leave the store, grabbing and pushing owner, who tried stopping her during the theft offense.

On 5/14/08, at 1854 Hrs., Ptl Robinson and I were detailed to 15729 Madison on the report of a business owner who was attempting to stop a shoplifter. Dispatch said that she could hear the two fighting and sent cars code 3.

On arrival we located ARA/DORIS WILKINS, VIC/KATHLEEN CURRAN and WIT/LINDA KEAN-LORMAN in front of 2005 Carabel. KEAN-LORMAN said that she was in CURRAN'S store, Goddess Blessed, and heard a display tip over. She observed WILKINS carrying 3 bottles of scented oils in her hand. WILKINS then put the bottles into her coat pocket and started to head to the front door to leave the store. KEAN-LORMAN said that she alerted CURRAN of the theft.

CURRAN said that she stopped WILKINS right at the door. CURRAN said that she confronted WILKINS about the theft. WILKINS produced the scented oils but would not give them to CURRAN. CURRAN advised WILKINS that she was calling the police, while standing in the doorway. CURRAN said that WILKINS grabbed her left wrist trying to get her to move out of the way. CURRAN had to peel WILKINS' hand from her wrist. CURRAN struggled to get the oils from WILKINS. WILKINS then shoved CURRAN out of the doorway and left the store. CURRAN and KEAN-LORMAN followed WILKINS to in front of 2005 Carabel.

In speaking to WILKINS she denies any knowledge of a theft. I could detect a strong odor of an alcoholic beverage about her person. She had bloodshot and glassy eyes and slurred speech. WILKINS admits to consuming at least a 6 pack prior to being stopped.

CURRAN produced the 3 bottles of scented oils that she recovered. I photographed them and CURRAN kept possession of them. CURRAN said that she does wish prosecution and gave a written statement.

WILKINS was placed under arrest, handcuffed and secured in the rear of car #203. She was transported to LPD in by Ptl Robinson. WILKINS was booked in by Co Bunner, Disp Sykora and I for Robbery and DCI. No citation was issued for the DCI due to the felony charge.
