Topic Original Report

M.O.: By forcefully entering through a rear door and taking an unknown quantity of WWII era rifles/pistols without the owner's consent.

SGT Favre, Sir,

Detailed to 18251 Detroit on 5/19/2008 at 1246hrs on the report of a breaking/entering. Dispatch advised that a business office had been forcefully entered and guns were taken. Arrived and spoke with COM/HARRY YEE JR.

YEE JR stated that the office belongs to his father, VIC/HARRY YEE SR. YEE JR showed me inside of the office. The office is in total disarray. Items are strewn about in no particular order. Remaining rifles, pistols, and other WWII memorabilia are not secured or organized. YEE JR advised that it is hard to tell what mess the suspect(s) made due to the mess that had already been present. YEE JR advised that he was last at the business office on 5/15/2008 at about 1000hrs. YEE JR was alerted to the break-in by his sister, OIV/LILLY YEE, on 5/18/2008 at about 1300hrs. YEE JR responded to the office and re-secured the damaged rear door on 5/18/2008. The rear door to the office is located in a hallway which connects it to 1409 Maile. The hallway can only be accessed from two points, both of which YEE JR claims are "always" locked. No evidence of forced entry was found to the hallway, only to the office's rear door. YEE SR did not request that LPD be notified until after he could survey the damage on 5/19/2008, accounting for the delay between discovery/notification. INV KULCZYCKI was detailed for photos.

It should be noted that YEE SR suffers from multiple health/age related issues. I spoke with YEE SR, but was only able to get basic information. YEE SR'S mental health is deteriorating, making it difficult to communicate with him. YEE JR and LILLY help to take care of him and his affairs. LILLY had been helping out around YEE SR'S apartment on the day she discovered the break-in. YEE JR is partially responsible for the listed office and takes care of other properties that YEE SR owns.

Approximately 150-200 WWII vintage pistols/rifles are stored in the listed office by YEE SR. Stolen were the approximately 50-100 listed Japanese 6.5x50mm or 7.7x50mm Arisaka rifles, Japanese 7mm or 8mm Nambu pistols, German 8mm Mauser rifles, Broomhandle 7.63x25mm Mauser pistols, and German 7.65x22mm or 9x19mm Luger pistols. The exact caliber of each weapon taken is unknown, as most of the weapons were originally made to various specifications. The stolen firearms were not secured in any cases or displays. They were mostly piled up on different tables, shelves, or loosely stuffed into cardboard boxes. Many rifles remain at the office, as the majority of items stolen were pistols. It is unclear what, if any, ammunition was taken. Nothing else appeared to be missing. YEE JR helped inventory YEE SR'S gun collection a few weeks ago, recording many serial numbers, makes, models, and taking photographs. YEE JR is compiling a list of items stolen w/serial numbers and photos. YEE JR will also attempt to calculate the values of the stolen items. YEE JR advised that it may take "a few days" to finish the list due to the disorganization of the office.

YEE JR and YEE SR do not know who may have committed the theft. YEE JR advised that YEE SR

will prosecute if an arrest is made. YEE JR was advised to store the remaining firearms in a more secure location.

It should be noted that LILLY was unavailable for questioning and that her NMI could not be completed at the time of this report. YEE JR was able to provide a good cell phone number, but there has been no answer to this point. LILLY usually assists YEE SR at his listed address at around 1800hrs daily.

Due to the area in which the rear door to the office is located, only one of the nearby apartments is in a reasonable position to have heard or seen anything involving the incident. The resident of this apartment, the one located closest to the rear door, was not available at the time of this report.

GOV/S.A. DON ILLIG of the ATF was notified of the incident.

A BOLO including the listed items was generated and broadcast by DISP SYKORA.
