N A R R A T I V E 1	Topic	Original Report
<p>Detailed on 5-20-08 at about 1344 Hrs. to the front counter of LPD to speak with a male about a problem he was having with CPY/CALANNI'S AUTO SERVICE. On my arrival I met COM/SCOTT MOIR who relayed the following.</p> <p>MOIR stated that in late February/early March he had a problem with the indexed auto. Being new to the area he took the car in for repairs to CALANNI'S AUTO SERVICE. After being in the shop for a short time he was told by SUB/CHARLES CALANNI that the fuel pump was bad. CALANNI kept the auto for a few more days after that. MOIR stated that he felt CALANNI kept the auto in his shop for an unusual amount of time for what appeared to be on the surface an "easy fix". MOIR stated that he paid around \$400.00 for that repair.</p> <p>On 5-12-08, MOIR stated the auto died again. After waiting most of the afternoon for a tow, he had it towed back to CALANNI'S AUTO SERVICE. MOIR stated he only did so because he felt the correct repair was either never made or there may have been a defect in the fuel pump that CALANNI had installed. MOIR stated that for a few days, he was unable to get an answer from CALANNI as to what the problem was. On 5-17-08 he finally spoke to CALANNI. CALANNI would only say that the problem was electrical in nature and nothing more specific. MOIR stated he exchanged a few more phone calls starting around 5-19-08 but eventually felt he was "getting the runaround".</p> <p>MOIR stated that he kept walking to the business several times over the next several days to retrieve the auto and kept finding the business closed. After running into other customers on this date having the same dilemma, MOIR decided to go to LPD and report the matter.</p> <p>MOIR was advised that it appeared this matter was civil in nature. MOIR was advised that he should be sure to get a detailed receipt documenting what if any repairs were made to his auto. MOIR was then referred to the Better Business Bureau and to follow up with Lakewood Municipal Court if a civil action was necessary.</p> <p>MOIR was then transported to CALANNI'S AUTO SERVICE by this Officer in yet another attempt to collect the auto. MOIR was once again told to come back in a few hours as he had not yet totaled out his bill. CALANNI claimed he had not added on the towing charges yet but would do so shortly. MOIR stated CALANNI still would not say what repairs/diagnosis he had made for the auto but the total of this bill was in the neighborhood of \$250.00 at this time.</p> <p>I later learned that Ptl. Forristell also took two other similar reports regarding CALANNI'S AUTO SERVICE. See #08004135 and #08004136 for details.</p>
