Topic Original Report

MO:By entering the victim's apartment and taking his guitar without his permission.

Sgt. WYNALEK Sir;

Dispatched to 12009 Clifton #4 on the report of a guitar missing from the apartment. On arrival, VIC/FELIPE AMUNATEGUI advised the following:

While out this morning, someone stole the listed guitar from his family room. AMUNATEGUI showed me the rear of the apartment, which has a door that leads from the kitchen to the outside, which was locked while he was gone. Next to the door is a large window, which AMUNATEGUI said is usually kept unlocked. There are various items that were stacked on top of the window sill. AMUNATEGUI advised that when he came home, all of the items from the window sill had been knocked over and the window was open. AMUNATEGUI further advised that the back door was now unlocked. It appears the suspect(s) gained entry by opening the window, then reaching inside to unlock the door, allowing themselves inside. This was the point of entry/exit.

The guitar was sitting on the floor of the family room. No other items in the apartment appeared to have been missing. It should be noted that there was a Nintendo Wii and several other valuable items left behind in plain sight. AMUNATEGUI has no suspects and was advised of solvability. He desires prosecution if a suspect is developed. AMUNATEGUI does not have insurance that covers the theft of the guitar.

Inv. GEARY responded and found NOV. I attempted to speak with the residents of apartment number 3, which is the only other apartment on the floor, but there was no answer at the door.
