Topic Original Report

M.O. By breaking out side entry door window, entering business, and taking multiple food items without owners permission or knowledge.

On 5-23-08 at 1530 hours cars were detailed to 12906 Madison on report from VIC/JOHN RANN that the business had been broken into last night. Upon arrival, it was found that the east facing side entry door had its window broken out. The suspects appeared to have broken out the window by unknown means and then reached through the window and opened the door. Once inside of the business, the suspects had to break out the window of an interior door to gain access to the lobby of the business.

In the lobby area, the suspects stole the multiple listed food items from the two coolers located in the lobby. The cash register, which is located on a shelf between the lobby and kitchen, was moved and left turned upside down. The change that RANN had left in the cash register was still in the drawer. There was no currency left in the register over night. No other items were stolen.

There were multiple items in the restaurant that were turned over or dumped out, but no other items were taken. There is no alarm or security cameras in the business or in the area. The east facing side door is located in an unlit alley and would be difficult to be seen from the street.

There are also two east facing windows in the alley. Both windows appeared to have been attempted by the suspects. The screen had been pushed up in one of the windows and there were multiple hand and finger prints on the other window from attempts to open the window.

Inv. Kulczycki responded to the scene. See his E.T. sheet for additional information.

RANN did not have any suspects in the theft and desired prosecution.
