<p>MO- By having the indexed marijuana pipe with burnt residue concealed on his person.</p> <p>On 5/24/08, at 2157 hours, Ptl. Leanza, Aux. Wolf and I responded to 2138 Quail, to arrest ARA/JAMES SEIDOWSKI on a Breaking and Entering warrant. Upon arrival we observed loud music coming from the garage on the rear of the property. SEIDOWSKI is known to spend time hanging out in the garage. We approached the garage and smelled the strong odor of freshly burn marijuana. We were able to look inside the building and see SEIDOWSKI inside.</p> <p>I knocked on the side door and identified myself. SEIDOWSKI opened the door and I advised him he was under arrest. I placed him in handcuffs. A search incident to arrest yielded the indexed silver marijuana pipe with burnt residue in his front right coat pocket. There was also .1g of marijuana located on the table SEIDOWSKI was sitting in front of.</p> <p>I transported SEIDOWSKI back to LPD where I booked him into jail. I spoke to Det. Kirkwood who told me not to issue SEIDOWSKI any citations due to the felony charge. The marijuana and pipe were confiscated, tagged and secured down the drug chute in the property room.</p>
